NMPM, BLINEBRY OIL AND GAS POOL,
LEA COUNTY, NEW MEXICO**

Gentlemen:

Further to our telephone conversation of this morning, Mobil Exploration & Producing I.S. Inc. (MEPUS) as Agent for Mobil Producing Texas & New Mexico Inc., respectfully requests your authorization for an amendment to the above order to a Non-Standard Unit.

Presently, the order provides for the simultaneous dedication of Blinebry gas production from its E.O. Carson #9 and 14 wells located in Units E and C, respectively. to a standard 160-acres gas spacing and proration unit comprising the NW/4 of Section 33, Township 21 South, Range 37 East.

Because of the Gas/Oil Ratio factor, the E.O. Carson #9 is now reclassified as an oil well. We are, therefore requesting that 40-acres be dedicated to this well as an oil well, and the remaining 120 acres be dedicated to our other well, the E.O. Carson #14.

The following items are being submitted in triplicate, in support of this request:

1. Forms C-102 - Well location and acreage dedication plats for each well.
2. Current listing of offset operators.
