DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Run 9 sts (407') 9-5/8" OD 36% grade 4-55 SB casing. 100 are cemented at 421' with 375 sacks Regular Neat cement. Plug at 400'. Maximum pressure 250#. Job comple 2:30 AM 7-4-54. Circulated approximately 60 sacks.

After waiting over 24 hours tested 9-5/8" casing with 1000# for 30 minutes. There was no drop in pressure. Drilled plug from 400' to 421' and tested cement below casing shoe with 100# for 30 minutes. There was no drop in pressure.
