DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

The following work was done the this well to shut off water coming into the well through a leak in the casing:

Pulled 2-1/2" tubing and re-ran with Lane-Wells 2-1/2" x 7" Hook-wall packer, which was set inside the 7"OD oil string at 3720'. Before setting packer well was making approximately 70% water, and this percentage was not materially helped by the packer setting, however the well increased in productivity apparently due to reducing pressure loss through the casing leak.
