FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

1. Pull rods, pump. Tag bottom with tubing and tally out of hole.
2. If necessary, run 4-3/4" bit and clean out to 3910 feet.
3. Fire 500 grain Dia-Log string shot from 3865 to 3905 feet.
4. Fire 1000 grain Dia-Log string shot from 3865 to 3905 feet.
5. Run open hole caliper and induction log from 3910 to 3834 feet.
6. Run tubing with open hole formation packer (setting determined from logs.)
7. Acidize with 7,500 gallons N.E. retarded acid.
8. Release packer and pull tubing.
9. Rerun tubing, rods, and pump and return to production.
