Run GR,CCL, CBL & CET. 4062' to 3100'. Perf casing w/4" guns 1 JHPF 3986 to 4004' (18 holes) Acidize perfs w/1300 gallons 15% NEFE HCL. Swab, TIH w/ CICR to 3975'. Sqz perfs 3986-4004, Test to 2000psi, ok. pmp 100sx Class C tail w/100sx Class C, 133 sx into formation. Perf casing w/ 1 JHPF 3834-3848, 3852,3862,3864,3882,3904,3918. Total 56 holes, pmp 4500 gallons 15% NEFE HCL. Swab. RIH w/ 2 3/8" prod. tbg. Well tubed to 3945. Finish running production equipment. Load tubing and test pmp to 650psi, ok. Turned over to production. Work performed 8-23-87 through 8-26-87.
