Moved in service unit 1-9-84 and killed well with 9 BW. Cemented from 9265'-9059' with 42 sx class H cement. Spotted 174 bbl brine gel from 9059'-5125'. Spotted 29 sx class C cement from 5275'-5125'. Spotted gelled brine from 5125'-3200'. Spotted 19 sx class C cement from 3200'-3100'. Spotted gelled brine from 3100'-900'. RIH with 4" casing gun and perforated 899'-900' with 4 JSPF. Circulated 7-5/8"-10-3/4" annulus. Ran 7-5/8" cement retainer set at 702'. Pumped through retainer with 300 sx class C cement. Circulated 40 sx of cement. Stung out of retainer and pulled up to 50' and spotted 10 sx class C cement surface plug. Cut off head and anchor. Installed PXA marker and moved out service unit 1-11-84.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
