Purpose: Pressure Test 5 1/2" Casing

The Wills Federal Well No. 1 has been temporarily abandoned since March 14, 1984. A cast iron bridge plug was set at 3100' with (2) sacks of cement on top. In order to continue the T.A. status for this well the 5 1/2" production casing will be tested. Marathon will load the hole with fluid and pressure test the casing to 500 psi with a kill truck. A chart recorder will be installed on the casing to detect any leakoff.

Marathon wishes to keep this well in T.A. status for further evaluation. The Hobbs BLM office will be notified prior to this work being performed.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
