Gentlemen:

El Paso Natural Gas Company respectfully requests Administrative approval under the provisions of Rule 5 (b) of Order No. R-520 of a Non-Standard Gas Proration Unit of 320 acres, more or less, comprising the S/2 of Section 22, Township 25 South, Range 37 East, N.M.P.M., Jalmat Gas Pool, Lea County, New Mexico and in support thereof states the following facts:

1. El Paso Natural Gas Company holds the Gas Operating Rights under the S/2 of Section 22, Township 25 South, Range 37 East, N.M.P.M.
2. That El Paso Natural Gas Company completed the El Paso Natural Gas Company-Carlson-Federal #1 Well in the NW/4 SW/4 of said Section 22, on September 1, 1955, with an Initial Potential of 16,500 MCF A.O.F. This well is located 1980 feet from the South line and 660 feet from the West line of said Section 22.
3. That the proposed Non-Standard Gas Proration Unit will meet the requirements of Rule 5 (b) of Order No. R-520 in that the proposed unit consists of contiguous quarter-quarter sections within a single governmental section, that the length or width thereof does not exceed
