The elevation of the derrick floor above sea level is 3070 ft.

DETAILS OF WORK

(State names of and expected depths to objective sands; show sizes, weights, and lengths of proposed casings; indicate mudding jobs, cementing points, and all other important proposed work)

We propose to drill this well to a TD of 7200'. 13-3/8" casing will be set at approximately 950' and cement circulated to surface. 9-5/8" casing will be set at approximately 3400' with DV Tool at approximately 1000'. Sufficient cement will be pumped around bottom of casing to bring cement to DV Tool and sufficient cement will be pumped through DV Tool to bring top of cement to bottom of 13-3/8" casing. This well is to be finally completed in the Brinkard and Fusselman Zones by running 7" casing to TD with DV Tool set at approximately 4000' and sufficient cement pumped around bottom of casing to bring cement to DV Tool and sufficient cement through DV Tool to bring cement to bottom of 9-5/8" casing. Two parallel strings of tubing will be run in order for each zone to produce through a separate string of tubing.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

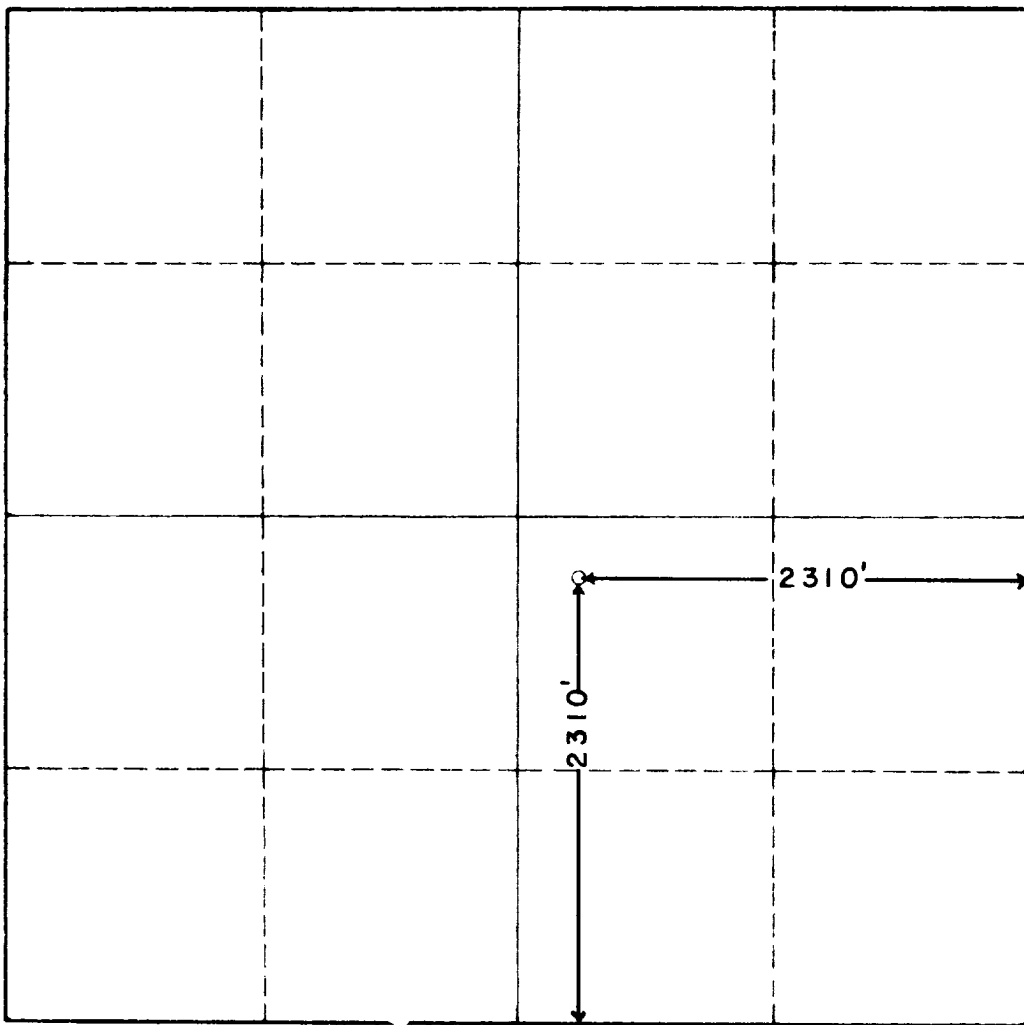
