COG Operating LLC requests administrative approval of a non-standard location for the Bandana Federal Com 602H, API number 30-025-Pending. The 602H well is proposed to be completed in the Fairview Mills; Bone Spring pool, Pool Code 96340. This pool has pool rules specifying the completed interval must be located 330 feet perpendicular from the exterior boundary of the applicable spacing unit.

Approval of the non-standard completed interval will allow for efficient spacing of horizontal wells and thereby prevent waste.


This will be a horizontal oil completion.
