Tap Rock Operating, LLC (OGRID No. 372043), pursuant to Division Rules 19.15.16.15(C)(6) and 19.15.15.13(C)-(D) NMAC and applicable rules governing acreage and well location requirements for the Purple Sage; Wolfcamp (Gas) pool [98220], seeks administrative approval of an unorthodox well location for its **Cypress 33 Fed Com # 208H well** (API No. 30-015-47846), in a 320-acre, more or less, spacing unit underlying the E/2 of Section 33, Township 23 South, Range 29 East, N.M.P.M., Eddy County, New Mexico.

The proposed surface and bottom hole locations and first and last take points are as follows:

- the surface location is located 23 feet from the south line and 974 feet from the east line (Unit P) of Section 28,
- the bottom hole location is located 30 feet from the south line and 331 feet from the east line (Unit P) of Section 33,
- the first take point is located 330 feet from the north line and 331 feet from the east line (Unit A) of Section 33 and

- the last take point is located 100 feet from the south line and 331 feet from the east line (Unit P) of Section 33.

Since this acreage is governed by the Division’s statewide rules, the completed interval for this well will be unorthodox because the last take point is closer (100 feet instead of 330 feet) than the standard offsets to the southern boundary of the spacing unit – thus encroaching on the N/2 of Section 4, Township 24 South, Range 29 East. Approval of the unorthodox, completed interval will increase the well’s effective lateral length by 230 feet, thereby increasing ultimate recovery of reserves and preventing waste of natural resources.

Exhibit A is a Form C-102 with attached plats showing the last take point of the proposed Cypress 33 Fed Com # 208H well encroaches on the spacing unit/tracts to the south in the N/2 of Section 4, Township 24 South, Range 29 East.

Exhibit B is a plat for the E/2 of Section 33, Township 23 South, Range 29 East, and the N/2 of Section 4, Township 24 South, Range 29 East, that shows the proposed Cypress 33 Fed Com # 208H well in relation to adjoining spacing unit/tracts to the south. OXY USA Inc. is the operator of a well in the affected spacing unit to the south. Additionally, the United States owns the mineral estate or a part thereof in the affected spacing unit. Accordingly, the “affected persons”¹ are OXY USA Inc. and the United States Bureau of Land Management. Included as **Exhibit C** is a waiver from OXY USA Inc. Therefore, notice only needs to be provided to the United States Bureau of Land Management.

Exhibit D is a spreadsheet listing all affected persons and includes tracking information demonstrating that each of the affected persons has either executed a waiver or was sent a copy of this application with all attachments by certified mail advising that any objections must be filed in writing with the Division within 20 days from the date the Division receives the application. 




LOCATION & ELEVATION VERIFICATION MAP




