Centennial Resource Production, LLC (OGRID No. 372165), pursuant to Division Rules 19.15.16.15(C)(6) and 19.15.15.13(C)-(D) NMAC and applicable rules governing acreage and well location requirements for the Ojo Chiso; Bone Spring, South pool [97293], seeks administrative approval of an unorthodox well location for its **Airstream 24 State Com #603H well** (API No. 30-025-49732), in a 640-acre, more or less, spacing unit underlying the W/2 of Sections 24 and 25, Township 22 South, Range 34 East, N.M.P.M., Lea County, New Mexico.

The proposed surface and bottom hole locations and first and last take points are as follows:

- the surface location is located 265 feet from the north line and 1578 feet from the east line (Unit B) of Section 24,
- the bottom hole location is located 100 feet from the south line and 2516 feet from the west line (Unit N) of Section 25,
- the first take point is located 100 feet from the north line and 2516 feet from the west line (Unit C) of Section 24 and

- the last take point is located 100 feet from the south line and 2516 feet from the west line (Unit N) of Section 25.

Since this acreage is governed by the Division’s statewide rules, the completed interval for this well will be unorthodox because it is closer than the standard offsets to the eastern boundary of the spacing unit – thus encroaching on the E/2 of Sections 24 and 25, Township 22 South, Range 34 East. As explained in engineering statement included as **Exhibit A**, approval of the unorthodox, completed interval will allow Centennial to use its preferred well spacing plan for horizontal wells in this area, which will maximize recovery and prevent waste.

**Exhibit B** is a Form C-102 showing the interval of the proposed Airstream 24 State Com #603H well encroaches on the spacing unit/tracts to the east in the E/2 of Sections 24 and 25, Township 22 South, Range 34 East.

**Exhibit C** is a plat for Sections 24 and 25, Township 22 South, Range 34 East, that shows the proposed Airstream 24 State Com #603H well in relation to adjoining spacing unit/tracts to the east. Exhibit B also includes an ownership list for the affected spacing unit to the east, showing that it is owned by Centennial and ConocoPhillips Company as working interest owners. In addition, the exhibit identifies that these are State leases. Accordingly, the “affected persons”<sup>1</sup> are the applicant, Centennial Resource Production, LLC, ConocoPhillips Company, and the New Mexico State Land Office.

**Exhibit D** is a spreadsheet listing all affected persons (other than the applicant, Centennial) and includes tracking information demonstrating that each of the affected persons was sent a copy of this application with all attachments by certified mail advising that any objections must be filed in writing with the Division within 20 days from the date the Division receives the application. Centennial Resource Production, LLC respectfully requests administrative approval on a non-standard location for the Airstream 24 State Com #603H to allow the completed interval to be less than 330 feet from the eastern boundary of the existing 640.00-acre horizontal spacing unit. This well is located in the Ojo Chiso; Bone Spring, South pool (97293). Due to the current spacing of the producing wells in this section, Centennial has planned the Airstream 24 State Com #604H and Airstream 24 State Com #605H wells with at least 900 feet of spacing between each well. This spacing pattern causes the Airstream 24 State Com #603H to be drilled less than 330 feet from the western boundary of the spacing unit. Centennial requests approval of this non-standard location to avoid causing wasted resources and reducing the production of the wells listed above.






