Tap Rock Operating, LLC (OGRID No. 372043), pursuant to Division Rules 19.15.16.15(C)(6) and 19.15.15.13(C) – (D) NMAC and applicable rules governing acreage and well location requirements for the Purple Sage; Wolfcamp (Gas) pool [98220], seeks administrative approval of an unorthodox well location for its Cypress 33 Fed Com 207H well (API No. 30-015-48297) (“Well”), in a 320-acre, more or less, horizontal spacing unit underlying the W/2 of Section 33, Township 23 South, Range 29 East, N.M.P.M., Eddy County, New Mexico.

The proposed surface and bottom hole locations and first and last take points are as follows:

Since this acreage is governed by the Division’s statewide rules, the completed interval for this well will be unorthodox because the first and last take points are closer (100 feet instead of 330 feet) than the standard offsets to the northern and southern boundaries of the spacing unit – thus encroaching on (1) the SW/4 of Section 28, Township 23 South, Range 29 East, and (2) the NW/4 of Section 4, Township 24 South, Range 29 East. Approval of the unorthodox, completed interval will increase the well’s effective lateral length by 460 feet, thereby increasing ultimate recovery of reserves and preventing waste of natural resources.

**Exhibit A** is a Form C-102 with attached plats showing the first take point of the proposed Well encroaches on the spacing unit/tracts to the north in the SW/4 of Section 28 and showing the last take point of the well encroaches on the spacing unit/tracts to the south in the NW/4 of Section 4.

**Exhibit B** is a plat for the W/2 of Section 33, the SW/4 of Section 28, and the NW/4 of Section 4 that shows the proposed Well in relation to adjoining spacing unit/tracts to the north and south. XTO Energy, Inc. is the operator of wells in the affected spacing unit to the north and OXY USA Inc. is the operator of the wells in the affected spacing unit to the south. Additionally, the United States owns the mineral estate or a part thereof in the affected spacing units. Accordingly, the “affected persons”<sup>1</sup> are XTO Energy, Inc., OXY USA Inc., and the United States Bureau of Land Management. **Exhibit C** contains waivers from XTO Energy, Inc. and OXY USA Inc. Therefore, notice only needs to be provided to the United States Bureau of Land Management.

**Exhibit D** is a listing of all affected persons and includes tracking information demonstrating that each of the affected persons has either executed a waiver or was sent a copy of this application with all attachments by certified mail advising that any objections must be filed in writing with the Division within 20 days from the date the Division receives the application. 




# LOCATION & ELEVATION VERIFICATION MAP





SECTION 33, TOWNSHIP 23-S, RANGE 29-E, N.M.P.M.



