Spur Energy Partners LLC respectfully requests administrative approval of a non-standard location on Goodman 22-23 51H, API Number 30-015-Pending, Property Code Pending. The 51H well is proposed to be completed in the N. Seven Rivers; Glorieta-Yeso pool, Pool Code 97565. The proposed wellbore is to be completed within 330’ feet of the N/2 of the S/2 of Sections 22 and 23. The proposed interval is projected as follows:

Surface Hole – 1888’ FSL 2158’ FWL Unit K Sec 22 T19S R25E
First Take Point – 2630’ FNL 2513’ FEL Unit G Sec 22 T19S R25E
Last Take Point – 2630’ FNL 2609’ FWL Unit F Sec 23 T19S R25E
Bottom Hole – 2630’ FNL 2659’ FWL Unit F Sec 23 T19S R25E

The adjoining units which the unorthodox location encroaches are located in T19S R25E, Section 22, Units I and J and Section 23, Units K and L.

Approval of the unorthodox, completed interval will allow for efficient spacing of horizontal wells and thereby prevent waste.




