**Martha Creek Battery Trains #2 and #4**

Each well will flow to an individual three-phase separator at the battery. The separator is equipped with an orifice meter to measure gas volume, as well as turbine meters to measure oil and water, although the wells does not produce liquid.

The gas meter serves as the BLM FMP meter for the well. Gas flow to sales will be handled through a pending gas commingle permit for the Indian Basin area.

**Additional Application Components:**

The flow of production is shown in detail on the enclosed facility diagram. Also enclosed is a map detailing facility, lease, and well location.


The oil and gas meters are calibrated on a regular basis per API, BLM and NMOCD specifications.

OXY USA WTP LP understands the requested approval will not constitute the granting of any right-of-way or construction rights not granted by the lease instrument.


**LEASE MAP**





