Mr. McClure,

Kaiser-Francis Oil Company ("KFOC") plans to drill the Brantley Fee 2419 1BSS 1H (API# 30-015-53367), 1BSS 2H (API# 30-015-53368), 2BSS 1H (API# 30-015-53369), and 2BSS 2H (API# 30-015-53370) wells on the same drilling pad which is to be located in the SW/4 of Section 24 23S-28E. The 1BSS wells are to target the First Bone Spring, while the 2BSS wells are to target the Second Bone Spring. Further, the 1H wells are to be located in the N/2 S/2 of Section 24 23S-28E and Section 19 23S-29E, while the 2H wells are to be located in the S/2 S/2 of Section 24 23S-28E and Section 19 23S-28E.

The subject wells are anticipated to be oil wells and completed in the following pool: Culebra Bluff, Bone Springs, South Pool. The Culebra Bluff, Bone Springs, South Pool, currently is spaced on a stacked forty basis. KFOC desires to seek a commingling order to commingle production from the above stated wells.

Bone Spring common source of supply in this portion of the state, the wells are be spaced on a stacked forty basis. In consulting with my Land Department, the royalty and working interests in the 1H and 2H are not homogenous. As a result, KFOC is working towards a commingling order to govern the 1H and 2H wells.

In an effort to ensure that production and costs are properly allocated to the proper wells, KFOC plans to handle gas, oil, and procured water in the following methods:

Each well will flow full well-stream into its own, unique three-phase separators. Gas from each separator will go through separate, electronic flow meters (EFM) for allocation purposes before going through a common gas sales meter provided by Crestwood.

Oil from the unique, three-phase separators will be measured with a Coriolis meter for allocation

purposes and flow into the 1BSS heater treater or 2BSS heater treater, depending on well. Once processed, oil from each treater will flow into commingled oil tanks. Oil from the commingled tanks will be pumped through a single Coriolis “check” meter before being sold through a LACT provided by Marathon. Any “reject” oil sales will be circulated back to a heater treater to be reprocessed.

Water from each three-phase separator will pass through separate turbine meters for allocation purposes before entering common water tanks. Water from the tanks will be pumped to disposal.

Gas pulled from the oil tank vent line and heater-treater vent lines will go through a separate Vapor Recovery Unit. Vapor gas will be measured by EFM before going through the sales meter. Vapor gas will be allocated back to the wells predicated upon the well’s oil production.


Since the royalty and working interest owners are slightly different between 1H and 2H wells, KFOC is sending out notifications to all affected parties.

# Brantley Fee Surface Commingling Lease Map






The boxes on the admin checklist collate to a number of different administrative orders which may be applied for. You may ignore all of the boxes in section 1 other than the one labeled for a CTB found under 1) B. [I].

Having said that, this application will not be able to be processed further at this point unless there is something I am misunderstanding. A commingling permit must include all wells being commingled prior to the sales meter. In this instance that will include any Marathon wells whose production is being sold at the referenced LACT. Additionally, it will need to be Marathon as the operator who operates the battery and LACT that must submit the surface commingling application. Included in that application should be a letter from Kaiser Francis supporting the application and a brief explanation regarding the relationship between Kaiser Francis and Marathon. If there is not a relationship such as being sister companies, then a brief explanation for why Kaiser Francis wishes to utilize another company's sales meter will need to be included.

**ORDER**

The Director of the New Mexico Oil Conservation Division (“OCD”), having considered the application and the recommendation of the OCD Engineering Bureau, issues the following Order.

**FINDINGS OF FACT**

1. Kaiser Francis Oil Company (“Applicant”) submitted a complete application to surface commingle the oil and gas production from the pools, leases, and wells identified in Exhibit A (“Application”).
2. Applicant proposed a method to allocate the oil and gas production to the pools, leases, and wells to be commingled.
3. To the extent that ownership is diverse, Applicant provided notice of the Application to all persons owning an interest in the oil and gas production to be commingled, including the owners of royalty and overriding royalty interests, regardless of whether they have a right or option to take their interests in kind, and those persons either submitted a written waiver or did not file an objection to the Application.
4. Applicant provided notice of the Application to the Bureau of Land Management (“BLM”) or New Mexico State Land Office (“NMSLO”), as applicable.

**CONCLUSIONS OF LAW**

5. OCD has jurisdiction to issue this Order pursuant to the Oil and Gas Act, NMSA 1978, §§ 70-2-6, 70-2-11, 70-2-12, 70-2-16, and 70-2-17, 19.15.12. NMAC, and 19.15.23. NMAC.
6. Applicant satisfied the notice requirements for the Application in accordance with 19.15.12.10.A.(2) NMAC, 19.15.12.10.C.(4)(c) NMAC, and 19.15.12.10.C.(4)(e) NMAC, as applicable.
7. Applicant satisfied the notice requirements for the Application in accordance with 19.15.23.9.A.(5) NMAC and 19.15.23.9.A.(6) NMAC, as applicable.
8. Applicant’s proposed method of allocation, as modified herein, complies with 19.15.12.10.B.(1) NMAC or 19.15.12.10.C.(1) NMAC, as applicable.
9. Commingling of oil and gas production from state, federal, or tribal leases shall not commence until approved by the BLM or NMSLO, as applicable, in accordance with 19.15.12.10.B.(3) NMAC and 19.15.12.10.C.(4)(h) NMAC.

10. By granting the Application with the conditions specified below, this Order prevents waste and protects correlative rights, public health, and the environment.

### **ORDER**

1. Applicant is authorized to surface commingle oil and gas production from the pools, leases, and wells identified in Exhibit A.

Applicant is authorized to store and measure oil and gas production off-lease from the pools, leases, and wells identified in Exhibit A at a central tank battery or gas title transfer meter described in Exhibit A.

2. The oil and gas production for each well identified in Exhibit A shall be separated and metered prior to commingling it with production from another well.
3. Applicant shall measure and market the commingled oil at a central tank battery described in Exhibit A in accordance with this Order and 19.15.18.15. NMAC or 19.15.23.8. NMAC.
4. Applicant shall measure and market the commingled gas at a well pad, central delivery point, central tank battery, or gas title transfer meter described in Exhibit A in accordance with this Order and 19.15.19.9. NMAC, provided however that if the gas is vented or flared, and regardless of the reason or authorization pursuant to 19.15.28.8.B. NMAC for such venting or flaring, Applicant shall measure or estimate the gas in accordance with 19.15.28.8.E. NMAC.
5. Applicant shall calibrate the meters used to measure or allocate oil and gas production in accordance with 19.15.12.10.C.(2) NMAC.
6. If the commingling of oil and gas production from any pool, lease, or well reduces the value of the commingled oil and gas production to less than if it had remained segregated, no later than sixty (60) days after the decrease in value has occurred Applicant shall submit a new surface commingling application to OCD to amend this Order to remove the pool, lease, or well whose oil and gas production caused the decrease in value. If Applicant fails to submit a new application, this Order shall terminate on the following day, and if OCD denies the application, this Order shall terminate on the date of such action.
7. Applicant shall not commence commingling oil or gas production from state, federal, or tribal leases until approved by the BLM or NMSLO, as applicable.
8. If OCD determines that Applicant has failed to comply with any provision of this Order, OCD may take any action authorized by the Oil and Gas Act or the New Mexico Administrative Code (NMAC).
9. OCD retains jurisdiction of this matter and reserves the right to modify or revoke this Order as it deems necessary.
