Re: Application of Tap Rock Operating, LLC's for Administrative Approval of Unorthodox Well Location.

Tap Rock Operating, LLC ("Tap Rock") (OGRID No. 372043) seeks administrative approval of an unorthodox well location for its **WTG Fed Com #123H well** (API No. 30-015-47041) to be completed within the WC-015 G-03 S262925D; Bone Spring Pool (98211) in a standard 222.86-acre, more or less, standard spacing unit underlying the W/2 E/2 of Section 27 and the W/2 NE/4 of irregular Section 34, Township 26 South, Range 29 East, N.M.P.M., Eddy County, New Mexico.

This well is to be drilled at the following location:

- Surface location: 288 feet from the north line and 915 feet from the east line (Unit A) of Section 27;
- Bottom hole location: 29 feet from the south line and 1870 feet from the east line (Lot 11) of Section 34;
- First take point: 330 feet from the north line and 1870 feet from the east line (Unit B) of Section 27;
- Last take point: 99 feet from the south line and 1870 feet from the east line (Lot 11) of Section 34.

Since this acreage is governed by the Division's statewide rules, the completed interval for the **WTG Fed Com #123H well** is unorthodox because the completed interval is closer than the standard offsets to the southern boundary of the spacing unit, thereby encroaching on the N/2 N/2 Section 4, Block 57, Township 1 North (Loving County, Texas). Approval of the unorthodox completed interval will allow Tap Rock to use optimal well spacing plan for horizontal wells in this area and thereby prevent waste.

Exhibit A is a Well Location and Acreage Dedication Plat (Form C-102), which shows that the completed interval of the proposed **WTG Fed Com #123H well** encroaches on the spacing units to the south.

Exhibit B is a land plat for Sections 27 and 34 that shows the proposed **WTG Fed Com #123H well** in relation to the adjoining spacing units to the south in the N/2 N/2 of Section 4, Block 57, Township 1 North (Loving County, Texas).

Ownership is diverse between the subject spacing unit and the affected spacing unit to the south. **Exhibit C** includes the tracking information that reflects the “affected parties” were sent a copy of this application with all attachments by certified mail advising that any objections must be filed in writing with the Division within 20 days from the date the Division receives the application. 


