
You have requested this non-standard horizontal spacing unit to maximize recovery, and to prevent waste within the Wolfcamp formation underlying the N/2 S/2 of Section 06, the N/2 S/2 of Section 05 and the N/2 SW/4 of Section 04 all while protecting the correlative rights within the referenced Horizontal Spacing Unit.

Pursuant to the authority conferred by Division Rule 19.15.16.15(B)(5) NMAC, the above-described **non-standard horizontal spacing unit is hereby approved**. Further, the Applicant may add additional wells to the horizontal spacing unit. The additional well(s) shall be designated to the same horizontal spacing unit and pool/formation. Submit a Change of Plans to the OCD's permitting website.
