You have requested this non-standard horizontal spacing unit in order to appease BLM's request need for a Com agreement for this spacing unit within the Wolfcamp formation. Thereby preventing waste and protecting correlative rights underlying the W/2 of Section 24 and the W/2 Section 13 within the referenced Horizontal Spacing Unit.

Pursuant to the authority conferred by Division Rule 19.15.16.15(B)(5) NMAC, the above-described **non-standard horizontal spacing unit is hereby approved**. Further, the Applicant may add additional wells to the horizontal spacing unit. The additional well(s) shall be designated to the same horizontal spacing unit and pool/formation.
