Devon Energy Production Company, L.P. (“Devon”) (OGRID No. 6137), pursuant to Division Rules 19.15.16.15(B)(5) and 19.15.15.11.B NMAC and applicable rules governing acreage and well spacing requirements for the WC-025 G-09 S223332A; UPR Wolfcamp Pool [98177], seeks administrative approval of a non-standard 640-acre, more or less, horizontal spacing unit comprised of the W/2 of Sections 13 and 24, Township 23 South, Range 32 East, NMPM, Lea County, New Mexico. The non-standard spacing unit will be dedicated to the following wells:


Devon Energy Production Company, L.P. ("Devon") respectfully requests approval of a non-standard Spacing Unit comprising the W2 of Sections 13 & 24 of 23S-32E, Lea County, NM, to develop the acreage as a single unit. Due to a difference in the federal royalty rates of the federal leases in the subject area, the Bureau of Land Management ("BLM") will not approve the commingling of production at central facilities if the subject area is developed using standard horizontal well spacing units. *See, e.g.*, 43 CFR 3173.14 (addressing authorized commingling). However, if the proposed non-standard spacing unit is approved by the Division, the BLM has stated it will issue a corresponding Communitization Agreement for the federal leases within the subject area, allowing Devon to produce all of the wells at a common facility, thereby reducing surface impacts, without giving rise to any commingling issues. Thus, approval of this application is necessary to meet BLM regulations, and to reduce waste and protect correlative rights within the referenced horizontal spacing unit.
