Re: Application of EOG Resources, Inc. for administrative approval of an unorthodox well location for its Rattlesnake 28 Fed Com 214H well dedicated to the W2 of Section 28 and N2 of the NW4 and Lots 3 and 4 of Section 33, Township 26 South, Range 33 East, NMPM, Lea County, New Mexico.

Dear Director Fuge,

EOG Resources, Inc. (OGRID No. 7377) seeks administrative approval of an unorthodox well location for its Rattlesnake 28 Fed Com 214H well (API No. 30-025-51966). The spacing unit dedicated to the well is comprised of the W2 of Section 28 and N2 of the NW4 and Lots 3 and 4 of Section 33, Township 26 South, Range 33 East, NMPM, Lea County, New Mexico and is within the Bradley; Bone Spring (7280). The horizontal spacing unit for the well is approximately 474.49 acres and does not include proximity tracts.

This well has not yet been drilled. It is proposed to be drilled as follows:

- The surface location is located 1016 feet from the North line, 2172 feet from the West line (Unit C) of Section 28,
- The bottom hole location is located 100 feet from the South line, 2360 feet from the West line (Lot 3) of Section 33,
- The first take point is located 100 feet from the North line, 2360 feet from the West line (Unit C) of Section 28,
- The last take point is located 100 feet from the South line, 2360 feet from the West line (Lot 3) of Section 33,

The acreage is governed by the Division's statewide rules. The proposed completed interval is unorthodox because it will be closer than 330 feet to the eastern boundary. It encroaches on the spacing units in the W2E2 of Section 28 and NWNE and Lot 2 of Section 33. Approval of the

unorthodox location will allow EOG to use its preferred well spacing plan for horizontal wells, which will prevent waste.

Exhibit A is the pending C-102 sundry that shows a change in the horizontal lateral, spacing unit, and well number change. This plat also shows the location of the proposed well, including the proposed unorthodox, completed interval. The proposed completed interval encroaches on the spacing unit/tracts to the east. The second page of Exhibit A is the approved original C-102 in the APD.

Exhibit B is a plat that shows the Rattlesnake 28 Fed Com 214H well in relation to the adjoining spacing units/tracts to the east.

Exhibit C is a certification from the landman indicating that he has reviewed the tracts affected by this request. Exhibit C includes a list of the affected parties and **Exhibit D** provides proof that a copy of this application, including exhibits, was mailed to each affected party. This notice advises affected parties that any objection must be filed in writing with the Division within 20 days from the date the Division receives the application.

Exhibit E is a statement from a petroleum engineer providing justification for the requested non-standard location.




