Reference is made to your application received on June 24th, 2024.

It is understood that this Directional well will be completed at an unorthodox location, as described above in the referenced pool or formation. This location is governed by Special Pool rule, R – 3816, which provides for wells to be within 150 feet of the center of a governmental quarter – quarter section or lot, establishing Set – back requirements to be 510 feet to any outer unit/lot boundary section line of the proration unit.

This well's completed interval is as close as 317 feet to the western boundary. Encroachment will impact the following tracts.

adjoining units towards which the proposed location encroaches. Notice is not required per Pool Rule, R-3816 Rule 5.

Division understands that you are seeking this orthodox location to allow for the most efficient development of this acreage within the Upper Penn formation underlying the W/2 SE/4 of Section 07. Thus, efficiently developing the acreage to prevent waste within the spacing unit.

Your application has been filed under Subsection 6 of Paragraph of Section (C) of 19.15.16.15 NMAC, 19.15.15.13 NMAC and Paragraph (2) of Subsection A of 19.15.4.12 NMAC.

Per Subsection B of 19.15.15.13 NMAC, **Division approves this unorthodox location.**

Reference this NSL order number on the As Drilled C-102 submitted with the Authorization to Transport, to place this well into production.
