Dear Acting Director Fuge:

Devon Energy Production Company, L.P., (“Devon”), OGRID No. 6137, is seeking administrative approval of an unorthodox well location (“NSL”) for the Fully Loaded 12-13 Fed Com 821H Well (the “821H Well”) (API No. 30-015-55039) to be completed within the Purple Sage; Wolfcamp (Gas) Pool (Pool Code 98220) underlying a standard 480-acre unit comprised of the SW/4 of Section 12 and the W/2 of Section 13, all in Township 24 South, Range 29 East NMPM, Eddy County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well that will be drilled as follows:

- Surface Location (SL): 2316’ from the North line and 1803’ from the West line (Unit F) of Section 12, Township 24 South, Range 29 East;
- Bottom Hole Location (BHL): 20’ from the South line and 1000’ from the West line (Unit M) of Section 13, Township 24 South, Range 29 East;
- First Take Point (FTP): 2553’ from the South line and 1000’ from the West line (Unit L) of Section 12, Township 24 South, Range 29 East;
- Last Take Point (LTP): 100’ from the South line and 1000’ from the West line (Unit M) of Section 13, Township 24 South, Range 29 East.

Devon has included as Exhibit B, a letter explaining why this application is needed. This well will produce from the Purple Sage Wolfcamp Pool (Pool Code 98220). The special Division rules for the Purple Sage; Wolfcamp (Gas) Pool establish 330' foot setback requirements which are laid out in Order No. R-14262. The first and last take points for the proposed well are closer than 330' from the boundary of the spacing unit.

The unorthodox location will encroach towards the (1) NW/4 of Section 12, Township 24 South, Range 29 East; and (2) the NW/4 of Section 24, Township 24 South, Range 29 East.

Devon attests that, on or before submission of this application, it provided notice to the affected persons (1) in the adjoining horizontal spacing unit which covers the NW/4 of Section 12 and the W/2 of Section 1, Township 24 South, Range 29 East and (2) in the adjoining horizontal spacing unit which covers the NW/4 of Section 24 and the N/2 of Section 23, Township 24 South, Range 29 East; said notice as described satisfies all provisions of 19.15.4.12A(2) NMAC; copies of the application and required plat maps were furnished. Devon has also provided notice to the Bureau of Land Management to the extent that federal leases are involved, pursuant to 19.15.2.7A(8)(d) NMAC. Devon provides herein a sectional map of this area, attached as Exhibit C. Proof of mailing, along with a copy of the notice letter sent to listed affected persons and parties, is attached hereto as Exhibit D. Devon has not identified a pooling case associated with this application.

Devon Energy Production Company, LP ("Devon") respectfully requests administrative approval of a non-standard location for the Fully Loaded 12-13 Fed Com 821H (the "Well") referenced above. The Well is in the Purple Sage; Wolfcamp Pool (Pool Code 98220) with first and last take points planned at roughly 100' FNL and FSL, respectively. It is Devon's responsibility as a prudent operator to minimize reserves left in the ground. Decreasing the first and last tank points from 330' will allow for increase in potential completed horizontal lateral, thereby increasing the ultimate recovery of reserves and thereby preventing waste of natural resources.


