Dear Mr. Lowe:

Pursuant to Division Rule 19.15.15.13, Mewbourne Oil Company (“Mewbourne”) respectfully requests administrative approval of an unorthodox gas well location for the above captioned well. This well will be drilled as a horizontal gas well in the Upper Wolfcamp Pool (98313).

The above well will be dedicated to a standard 480-acre gas spacing and proration unit comprising the SW/4 of Section 28 and the W/2 of Section 33.

The Upper Wolfcamp Pool is currently governed by Special Pool Rules, Hearing Order No. R-14262 which requires standard 320-acre gas spacing and proration units with wells to be located no closer than 330 feet to the outer boundary of the spacing unit, nor closer than 10 feet to any interior quarter-quarter section line or subdivision inner boundary, or in the case of a horizontal well, no closer than 330 feet to the outer boundary of the producing area.

The unorthodox location is necessary in order to maximize the recovery of oil and gas reserves from the Wolfcamp formation underlying the SW/4 of Section 28 and the W/2 of Section 33.

The affected offset acreage comprises the SE/4 of Section 28 and the E/2 of Section 33, Township 21 South, Range 32 East, NMPM (See Attached Map), which is operated by Mewbourne Oil Company.

Attached is a Form C-102 showing the surface, first take point, and bottomhole locations for the above captioned well. Also, attached is a map showing the affected offset acreage, a horizontal well plan, and a notice list.




