Dear Director Fuge/OCD Engineering Bureau:

Pursuant to Division rules 19.15.16.15(C)(6) and 19.15.15.13 NMAC, Franklin Mountain Energy 3, LLC ("Franklin") (OGRID 331595) seeks administrative approval of an unorthodox well location ("NSL") for its Tag State Com 804H well (API No. 30-025-52730) (the "Well"). The Well will be located in a 641.27-acre,<sup>1</sup> more or less, standard spacing unit underlying Lots 1 and 2, S/2 NE/4 and the SE/4 of irregular Section 2 (E/2 equivalent) and the E/2 of Section 11, Township 20 South, Range 35 East, Lea County, New Mexico. C-102s for the Well are attached as Exhibit A.

As the C-102s demonstrate, the Well will traverse both Sections 2 and 11, Township 20 South, Range 35 East. The pool and pool code for Section 2 is the Pearl, Wolfcamp, South Pool (Pool Code 49870), which is an oil pool. The Well is at an orthodox (standard) location in Section 2, and thus Franklin does not

need non-standard location approval for Section 2. The pool underlying Section 11 is, however, a gas pool—Lea; Wolfcamp (Gas) (Pool Code 80060). Because the pool underlying Section 11 is a gas pool, Franklin is requesting a non-standard location *only* for that portion of the Well that traverses Section 11.<sup>2</sup>

The Lea; Wolfcamp (Gas) Pool is a gas pool subject to the state-wide rules, which establish a 660' setback requirement for the completed laterals of gas wells and a 330' setback for last take points. The Well's completed lateral will be closer than 660' from the outer boundary of the spacing unit in Section 11 and the Well's last take point will be closer than 330' in Section 11, which requires an NSL approval. As shown on Exhibit A, this is a horizontal well that will be drilled as follows:

- Surface Hole Location: 266' FNL & 1,066' FEL of Section 2-T20S-R35E;
- First Take Point: 100' FNL & 360' FEL of Section 2- T20S-R35E (Standard Location);
- Last Take Point/Bottom Hole Location: 100' FSL & 360' FEL of Section 11- T20S-R35E (Non-Standard Location).

Franklin has included as Exhibit B a letter explaining why this application is needed.

Franklin also provides a map of the area, attached as Exhibit C, which shows the tracts upon which the unorthodox location will encroach. As discussed above, the completed lateral of the Well is proposed to be closer than 660' from the boundary of the spacing unit and the last take point is proposed to be closer than 330'. See Exhibit A (C-102). The unorthodox location will encroach towards the W/2 of Section 12, the NE/4 of Section 14, the NW/4 of Section 13, and the SW/4 of Section 1, Township 20 South, Range 35 East.

Pursuant to Rule 19.15.4.12(A)(2) and Rule 19.15.2.7(A)(3), Franklin, through its undersigned counsel, provided notice to the operators and/or working interest owners identified in the offset owner chart included in Exhibit D and is also providing notice to the Bureau of Land Management and the New Mexico State Land Office. Proof of mailing, along with a copy of the notice letter sent to affected parties, is attached hereto as Exhibit D.

***Franklin respectfully requests expedited review of this NSL application for several reasons.*** First, Franklin has approved permits and is hoping to receive its approved pooling orders in the near term. Second, the Tag State wells are on Franklin's rig schedule with an anticipated start date of October 1<sup>st</sup>, 2024. If the NSL is not approved, Franklin would need to move its bottom hole locations but

that would result in waste and would not result in the most efficient recovery from the Well. If the pool underlying Section 11 was the same pool as under Section 2, Franklin would not need a non-standard location approval, and so approving the NSL in an expedited fashion so that Franklin does not need to shorten its laterals or otherwise move its laterals in Section 11 is, in Franklin's opinion, prevents waste and protects correlative rights.

Your attention to this matter is appreciated.




Franklin Mountain Energy 3, LLC ("Franklin"), OGRID Number 331595, respectfully requests administrative approval of non-standard location ("NSL") for the following well (the "Well"):


- Tag State Com 804H well (API No. 30-025-52730)

The Well will be located in the E/2 of Sections 2 and 11, Township 20 South, Range 35 East, Lea County, New Mexico. The Well will be completed in two pools: The first take point and first half of the completed lateral will be in Section 2, which is in the Pearl; Wolfcamp, South Pool (Pool Code: 49870), which is an oil pool. The second half of the completed lateral and the last take point will be in Section 11, which is the Lea; Wolfcamp (Gas) Pool (Pool Code: 80060), which is a gas pool. The Well's first take point and completed lateral in Section 2 are standard under the Division's rules for oil pools. The Well's last take point and completed lateral in Section 11 are non-standard under the Division's rules for gas pools (but would be standard if the pool were an oil pool). Franklin is requesting non-standard location approval for the portion of the Well that traverses Section 11 to allow the setbacks to be less than 660' from the outer boundary of the horizontal spacing unit and for the last take point to be closer than 330' from the outer boundary. Allowing Franklin to complete the well at this non-standard location will result in the greatest recovery of reserves from the unit and will reduce waste.







Tag State Com 804H well identified by orange dashed
