Pursuant to Division Rule 19.15.16.15(B)(5), Mewbourne Oil Company ("Mewbourne") respectfully requests administrative approval of a non-standard proration unit for its proposed Salado Draw 9 wells listed above. These wells will be drilled as horizontal oil wells in the Bradley Bone Spring (Oil) Pool (7280). The current spacing units are 160 acre units, made up of 40 acre building blocks for the pool rules. Mewbourne is seeking an expanded 320 acre unit.

The Salado Draw 9 Fed Com #561H and #563H will be dedicated to a standard 320-acre oil spacing and proration unit comprising all of Section 9. There are currently no other existing Bone Spring Oil wells producing from within the proposed spacing unit.

The non-standard proration unit is necessary in order to maximize the recovery of oil and gas reserves from the Bone Spring formation underlying all of Section 9.

The affected offset acreage comprises the SE/4SE/4 of Section 5, NE/4NE/4 of Section 17, S/2SW/4 & SW/4SE/4 of Section 4, N/2NW/4 & NW/4NE/4 of Section 16, E/2E/2 of Section 8, and the W/2W/2 of Section 9 all in T26S-R33E, Lea County, New Mexico. There is currently Bone Spring production within the offset acreage. Consequently, notice of this application is being provided to all parties listed on the attached list of affected parties.

Attached are the Form C-102s showing the surface, first take point, and bottomhole locations for the Salado Draw 9 Fed Com #561H and #563H. Also, attached is a map showing the affected offset acreage, a horizontal well plan, notice list and offset notice letter.

Mewbourne is seeking approval of this NSP to eliminate the need for separate production facilities and additional administrative approvals. Therefore, reducing waste while protecting correlative rights within the referenced horizontal spacing unit.






NSP Map
