On behalf of Blackbuck, ALL has prepared the attached letter requesting a one-year extension for the Injection Permit of their Patriot 9 State SWD #1 (Order No. SWD-2380, API # 30-015-48074). As stated in the letter, injection authority for the Subject SWD was originally granted to Cimarex Energy Co. (Cimarex) via Administrative Order # SWD-2380 and the Drill Permit was approved by OCD on February 25, 2021. Blackbuck subsequently purchased the Subject SWD from Cimarex and the C-145 confirming the transfer was approved by OCD on April 8, 2021. As such, **Blackbuck has only owned the Injection Permit for 6 months** and is requesting a one-year extension of the Injection Permit to allow adequate time to drill, complete, and commence injection at the Subject SWD. Blackbuck plans to drill and operate the well in the next year, but based on the ongoing Covid-19 pandemic, and various other industry considerations, it is difficult to provide an exact date of when this well will be spudded and put into operation.

As demonstrated in the attached request package, there are no new affected parties within the AOR that are required to be notified of the extension and no new wells within the 1-mile AOR penetrate the top of the proposed injection interval.


On behalf of Blackbuck Resources New Mexico LLC (Blackbuck), ALL Consulting, LLC (ALL) is requesting an extension of the Injection Permit for their Patriot 9 State SWD #1 (Subject SWD), a proposed saltwater disposal well, in Eddy County, NM.

Injection authority for the Subject SWD was originally granted to Cimarex Energy Company (Cimarex) via Administrative Order # SWD-2380 and the Drill Permit was approved by OCD on February 25, 2021 (API # 30-015-48074). Blackbuck subsequently purchased the Subject SWD from Cimarex and the C-145 confirming the transfer was approved by OCD on April 8, 2021. As such, Blackbuck has only owned the Injection Permit for the Subject SWD 6 months and is requesting a one-year extension of the Injection Permit to allow adequate time to drill, complete, and commence injection at the Subject SWD. Blackbuck plans to drill and operate the well in the next year, but based on the ongoing Covid-19 pandemic, and various other industry considerations, it is difficult to provide an exact date of when this well will be spudded and put into operation.

ALL reviewed operators and leaseholders within the AOR and confirmed that no new Affected Parties are present with the AOR; therefore, no new Affected Parties are required to be notified of the extension. Additionally, ALL conducted an updated AOR evaluation and confirmed that no new wells are present within the AOR that penetrate the top of the proposed injection interval.
