BTA Oil Producers, LLC ("BTA") (OGRID No. 260297), pursuant to Division Rules 19.15.16.15(B)(5) and 19.15.15.11 NMAC, seeks administrative approval of Non-Standard Horizontal Spacing Unit for its Bobtail 8605 26-23 State Com #1H and #2H wells ("Wells"), in a 640-acre, more or less, non-standard horizontal spacing unit underlying the E/2 of Sections 26 and 23, Township 20 South, Range 35 East, Lea County, New Mexico.

BTA's request for approval of a non-standard spacing unit will allow it to consolidate surface facilities and will consequently prevent surface, environmental, and economic waste. The non-standard unit will allow BTA to minimize surface use. Centralizing equipment for facilities for the wells will reduce the total acreage needed for surface facilities. Further a common surface facility reduces the number of flares BTA may need to use in the case of emergency from 4 to 2. Additionally, the VOC reduction is nearly 50%. Therefore, to obtain maximum lateral length, create cost efficiencies, prevent waste, and protect correlative rights, BTA respectfully requests approval of this non-standard location.

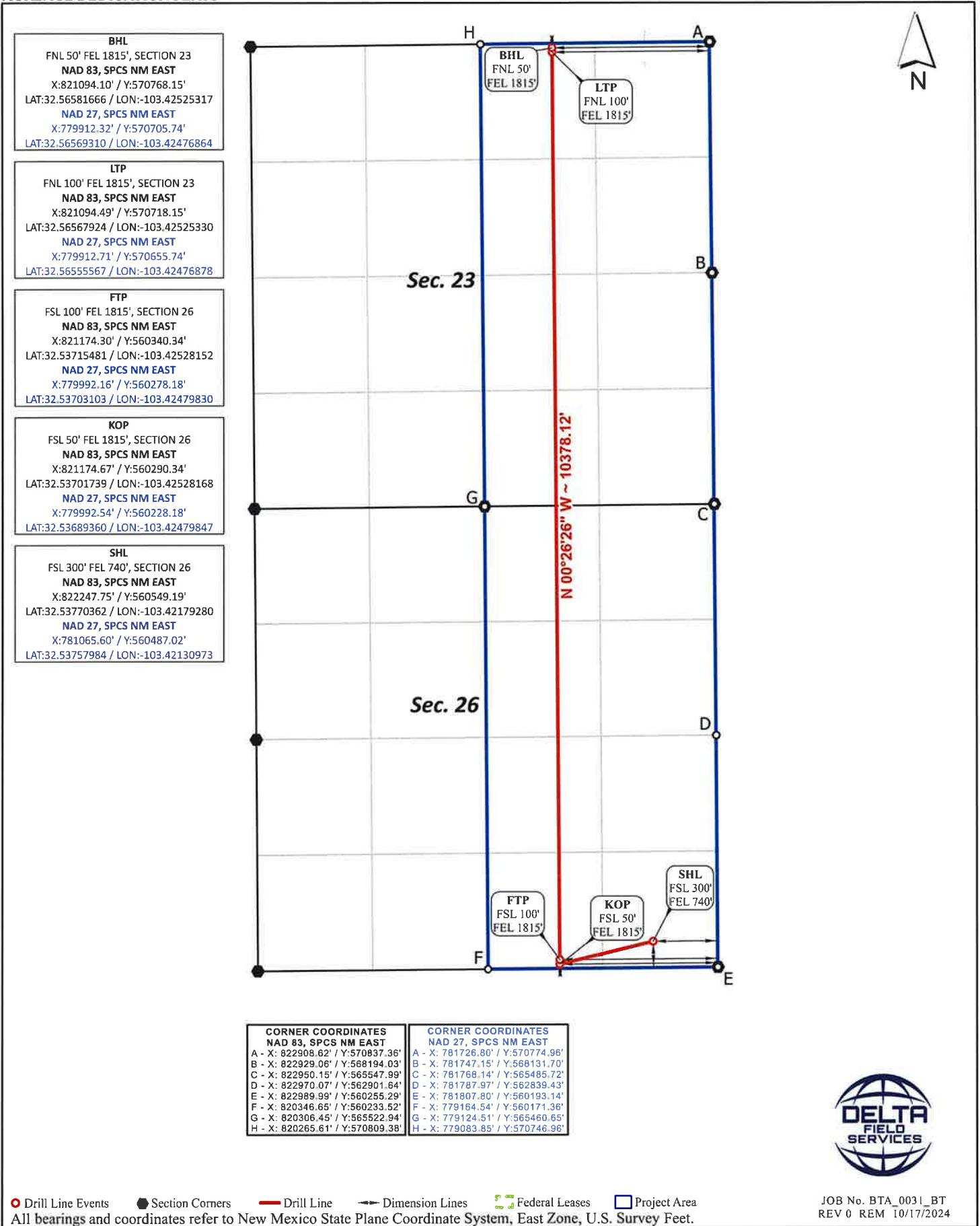

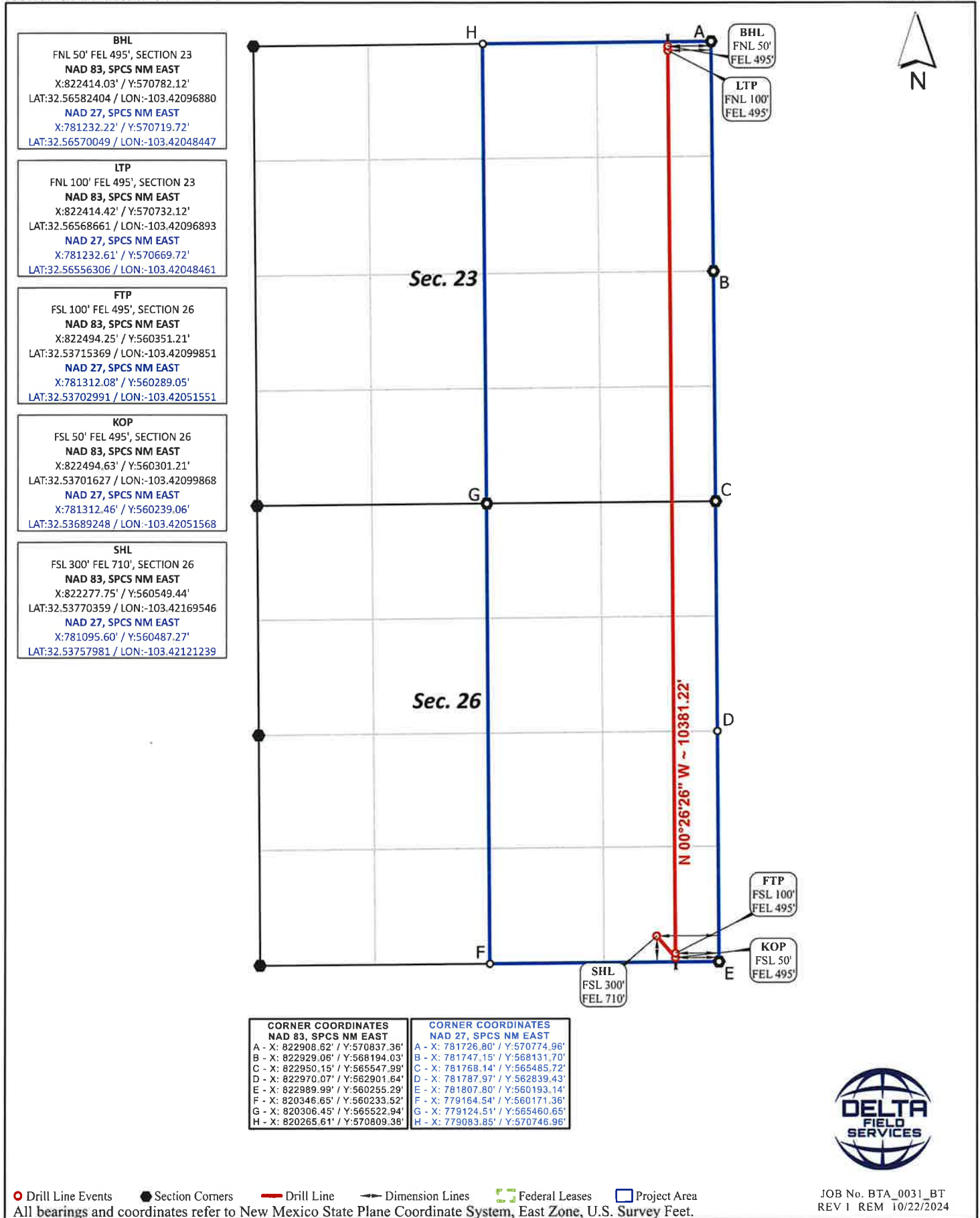

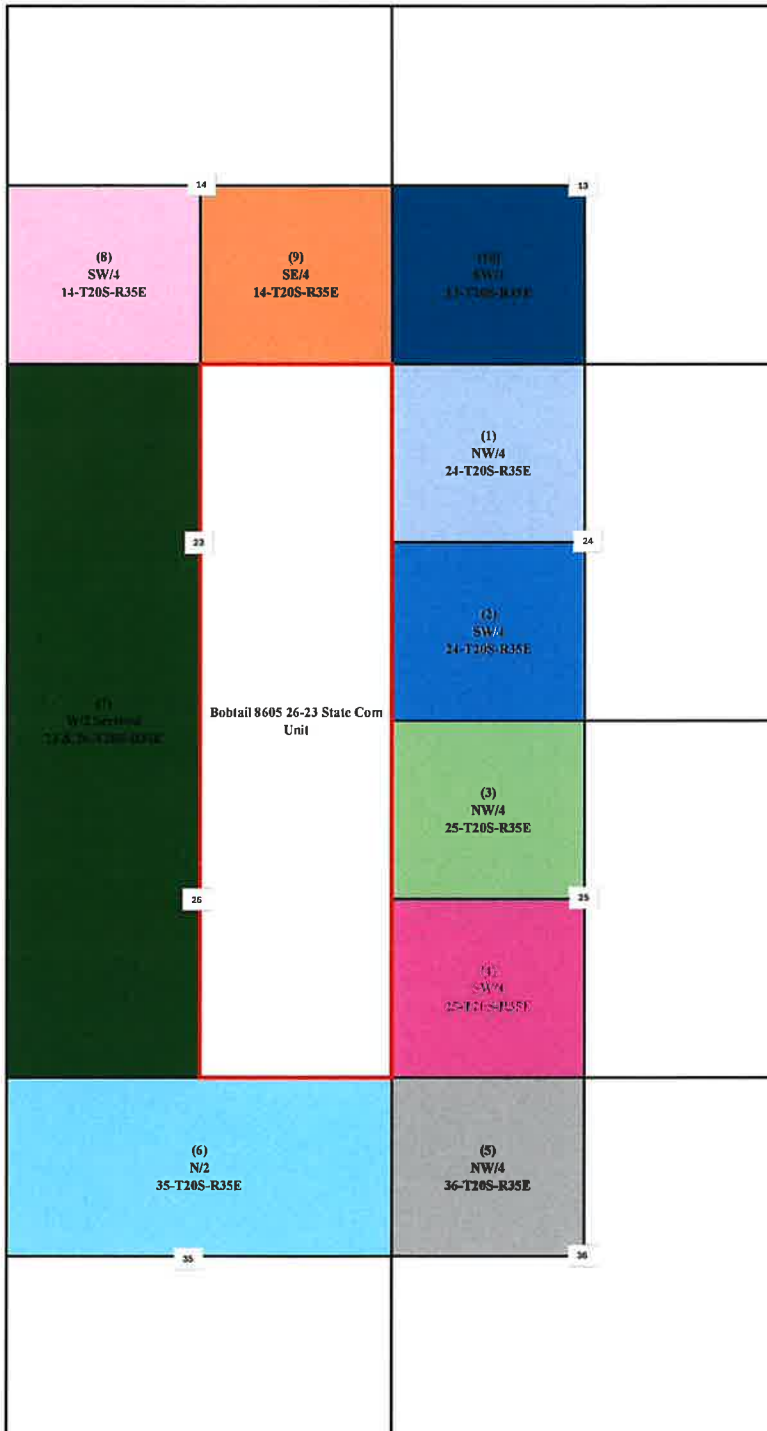
