You have requested to complete this horizontal well described above in the referenced pool or formation. Devon Energy Production Company, L.P., ("Devon"), OGRID No. 6137, is seeking administrative approval of an unorthodox well location ("NSL") for the Thoroughbred 10-3 Fed Com 826H Well (the "826H Well") (API 30-015-56775) located in the Purple Sage; Wolfcamp (Gas) Pool (Pool Code 98220) underlying a standard 640-acre, more or less, horizontal spacing unit comprised of the E/2 of Sections 10 and 3, all in Township 26 South, Range 31 East, NMPM, Eddy County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well to be drilled as follows:

- Surface Location (SL): 270' from the South line and 2240' from the East line (Unit O) of Section 10, Township 26 South, Range 31 East;
- First Take Point (FTP): 100' from the South line and 610' from the East line (Unit P) of Section 10, Township 26 South, Range 31 East;
- Last Take Point (LTP): 100' from the North line and 610' from the East line (Unit A) of Section 3, Township 26 South, Range 31 East;
- Bottom Hole Location (BHL): 20' from the North line and 610' from the East line (Unit A) of Section 3, Township 26 South, Range 31 East.

Devon has included as Exhibit B, a letter explaining why this application is needed. This well will produce from the Purple Sage; Wolfcamp (Gas) Pool (Pool Code 98220). The special Division rules for the Purple Sage; Wolfcamp Pool establish 330' foot setback requirements which are laid out in Order No. R-14262. The first and last take points for the proposed well are closer than 330' from the boundary of the spacing unit.

The unorthodox location encroaches toward NE/4 of Section 15, Township 26 South, Range 31 East and the SE/4 of Section 34, Township 25 South, Range 31 East, NMPM, Eddy County, New Mexico.

Devon attests that, on or before submission of this application, it sent notice to the affected persons/parties in (1) the adjoining horizontal spacing unit which covers the E/2 of Section 15, Township 26 South, Range 31 East; and (2) the adjoining horizontal spacing unit which covers the E/2 of Section 34, Township 25 South, Range 31 East, NMPM, Eddy County, New Mexico. Devon has also sent notice to the Bureau of Land Management ("BLM") to the extent that federal leases are involved, pursuant to NMAC 19.15.2.7A(8)(d); said notice as described satisfies all provisions of NMAC 19.15.4.12A(2); copies of the application and required plat maps were furnished. Devon provides herein a sectional map of this area, attached as Exhibit C. Proof of mailing, along with a copy of the notice letter sent to the affected persons, is attached hereto as Exhibit D. Devon has informed us that there is no pooling case associated with this application.



Decreasing the first and last take point from three hundred and thirty feet (330') to one hundred feet (100') will increase the wells effective lateral length by 460 feet thereby increasing ultimate recovery of reserves and thereby preventing waste of natural resources.


