On October 15, 2025, EOG Resources, Inc. ("EOG") notified the New Mexico Oil Conservation Division ("OCD") that it is protesting the following SWD permit request application of Blackbuck New Mexico, LLC ("Blackbuck") for disposal:

- Allegiance Federal SWD No. 1, Unit Lot 4, Section 5, Township 27 East, Range 25 South, Eddy County, New Mexico

EOG is identified as an affected person for the referenced application. For the application to proceed, Blackbuck has two options: either resolve the matter with the protesting party or go to a hearing before the Division. If the protest is withdrawn, then the application could be processed administratively. Meanwhile, OCD will retain your application until a resolution is reached on the status of the submittals.
