You have requested to complete this horizontal well described above in the referenced pool or formation. This well is governed by special rules R-14262, for the Purple Sage; Wolfcamp (Gas) Pool and governs wells to be located at least 330 feet from the unit outer boundary of a spacing unit and no closer than 10 feet to any quarter – quarter section line. The completed intervals of horizontal wells are to be located no closer than 330 feet to the exterior boundary of a standard 320 - acre spacing unit.

The request to deviate from an orthodox location has met all requirements of 19.15.16.15 (C)(5)(a) NMAC. It is understood that you are seeking this exception in order to create a non-standard location, comprised of Take Points referenced above, within the described Horizontal Spacing Unit.

This well's completed interval is as close as 74 feet to the northern edge of the horizontal spacing unit. Encroachment will impact the following tracts.

Section 13, encroachment to the NE/4

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in 19.15.2.7(A)(8) NMAC, in all adjoining units towards which the proposed location encroaches.

The Division understands you are seeking this unorthodox location in order to maximize the recovery of reserves within the Wolfcamp formation underlying the SE/4 Section 13, and E/2 Section 24, thereby maximizing recovery of resources and preventing waste.

Your application has been filed under 19.15.16.15(C)(6) NMAC, 19.15.15.13 NMAC and 19.15.4.12 (A)(2) NMAC.

Per 19.15.15.13 (B) NMAC, **Division approves this unorthodox location.**

Dear Mr. Lowe:

Pursuant to Division Rule 19.15.15.13, Mewbourne Oil Company ("Mewbourne") respectfully requests administrative approval of an unorthodox gas well location for the above captioned Fuller 13/24 Fed Com #827H well. This well will be drilled as a horizontal gas well in the Purple Sage Wolfcamp (Gas) Pool (98220).

The above well will be dedicated to a standard 480-acre gas spacing and proration unit comprising the SE/4 of Section 13 and the E/2 of Section 24.

The Purple Sage Wolfcamp (Gas) Pool is currently governed by Special Pool Rules, Hearing Order No. R-14262 which requires standard 320-acre gas spacing and proration units with wells to be located no closer than 330 feet to the outer boundary of the spacing unit, nor closer than 10 feet to any interior quarter-quarter section line or subdivision inner boundary, or in the case of a horizontal well, no closer than 330 feet to the outer boundary of the producing area.

The unorthodox location is necessary in order to maximize the recovery of oil and gas reserves from the Wolfcamp formation underlying the SE/4 of Section 13 and the E/2 of Section 24.

The affected offset acreage comprises the NE/4 of Section 13, T26S- R29E NMPM (See Attached Map). Consequently, notice of this application is being provided to Mewbourne Oil Company.

Attached is a Form C-102 showing the surface, first take point, bottomhole location, and last perf for the above captioned wells. Also, attached is a map showing the affected offset acreage, a horizontal well plan.

In summary, approval of the application will provide Mewbourne Oil Company the opportunity to recover additional oil and gas reserves from the Purple Sage Wolfcamp (Gas) Pool underlying the SE/4 of Section 13 and the E/2 of Section 24 that may otherwise not be recovered, thereby preventing waste, and will not violate correlative rights.




