You have requested to drill this horizontal well at an unorthodox well location described above in the referenced pool or formation. 19.15.16.15(B)(1)(a) NMAC governs this proposed well and provides that the operator dedicate a horizontal well at a standard horizontal spacing unit that comprises of one or more contiguous tracts that the horizontal well's completed interval penetrates, each of which consists of a governmental quarter - quarter section or equivalent.

19.15.16.15(C)(1)(a) NMAC governs the distance in the horizontal plane from any point in the completed interval to any outer boundary of the horizontal spacing unit, measured along a line perpendicular to the completed interval or to the tangent thereof, shall be a minimum of 330 feet for an **oil** well. 19.15.16.15(C)(1)(b) NMAC governs the first and last take point of a horizontal well shall be no closer than 100 feet for a well within the horizontal plane, to any outer boundary of the horizontal spacing unit.

The request to deviate from an orthodox location has met all requirements of 19.15.16.15 (C)(5)(a) NMAC. It is understood that you are seeking this exception in order to create a non-standard location, comprised of Take Points referenced above, within the described Horizontal Spacing Unit.

This well's completed interval is as close as 20 feet to the eastern edge of the horizontal spacing unit. Encroachment will impact the following tracts.

Section 10, T25S, R31E, encroachment to the E/2 E/2  
Section 03, T25S, R31E, encroachment to the E/2 E/2  
Section 34, T24S, R31E, encroachment to the E/2 E/2

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in 19.15.2.7(A)(8) NMAC, in all adjoining units towards which the proposed location encroaches.

The Division understands you are seeking this unorthodox location to maximize ultimate recovery of reserves by decreasing well spacing of the unit within the Bonespring formation underlying the W/2 E/2 section 10, T25S, R31E, the W/2 E/2 section 03, T25S, R31E and the W/2 E/2 section 34, T24S, R31E, thereby preventing waste.

Your application has been filed under 19.15.16.15(C)(6) NMAC, 19.15.15.13 NMAC and 19.15.4.12 (A)(2) NMAC.

Per 19.15.15.13 (B) NMAC, **Division approves this unorthodox location.**

Reference this NSL order number on the As Drilled C-102 submitted with the Authorization to Transport, to place this well into production.

Devon Energy Production Company, L.P., (“Devon”), OGRID No. 6137, is seeking administrative approval of an unorthodox well location (“NSL”) for the Exmoor 10-34 Fed Com 122H Well (the “122H Well”) (API Pending) located in the Paduca; Bone Spring Pool (Pool Code 96641) underlying a standard 477.2-acre, more or less, horizontal spacing unit comprised of the W/2 E/2 of Sections 10 and 3, in Township 25 South, Range 31 East, NMPM and the W/2 E/2 of Section 34, in Township 24 South, Range 31 East, NMPM, Eddy County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well to be drilled as follows:

- Surface Location (SL): 265’ from the North line and 524’ from the East line (Unit A) of Section 15, Township 25 South, Range 31 East;
- Bottom Hole Location (BHL): 20’ from the North line and 1340’ from the East line (Unit B) of Section 34, Township 24 South, Range 31 East;
- First Take Point (FTP): 100’ from the South line and 1340’ from the East line (Unit O) of Section 10, Township 25 South, Range 31 East;
- Last Take Point (LTP): 100’ from the North line and 1340’ from the East line (Unit B) of Section 34, Township 24 South, Range 31 East.

Devon has included as Exhibit B, a letter explaining why this application is needed. This well will produce from the Paduca Bone Spring Pool (Pool Code 96641). Statewide rules require that an oil well's completed interval shall be no closer than a 330' distance from the outer boundary of the horizontal spacing unit.

The unorthodox location encroaches toward E/2 E/2 of Sections 10 and 3, in Township 25 South, Range 31 East, NMPM and the E/2 E/2 of Section 34, in Township 24 South, Range 31 East, NMPM, Eddy County, New Mexico.

Devon attests that, on or before submission of this application, it sent notice to the affected persons/parties in the adjoining horizontal spacing unit which covers the E/2 E/2 of Sections 10 and 3, in Township 25 South, Range 31 East, NMPM and the E/2 E/2 of Section 34, in Township 24 South, Range 31 East, NMPM, Eddy County, New Mexico. Devon has also provided notice to the Bureau of Land Management ("BLM") to the extent that federal leases are involved, pursuant to NMAC 19.15.2.7A(8)(d); said notice as described satisfies all provisions of NMAC 19.15.4.12A(2); copies of the application and required plat maps were furnished. Devon provides herein a sectional map of this area, attached as Exhibit C. Proof of mailing, along with a copy of the notice letter sent to the affected persons, is attached hereto as Exhibit D. Devon has informed us that there is no pooling case associated with this application.



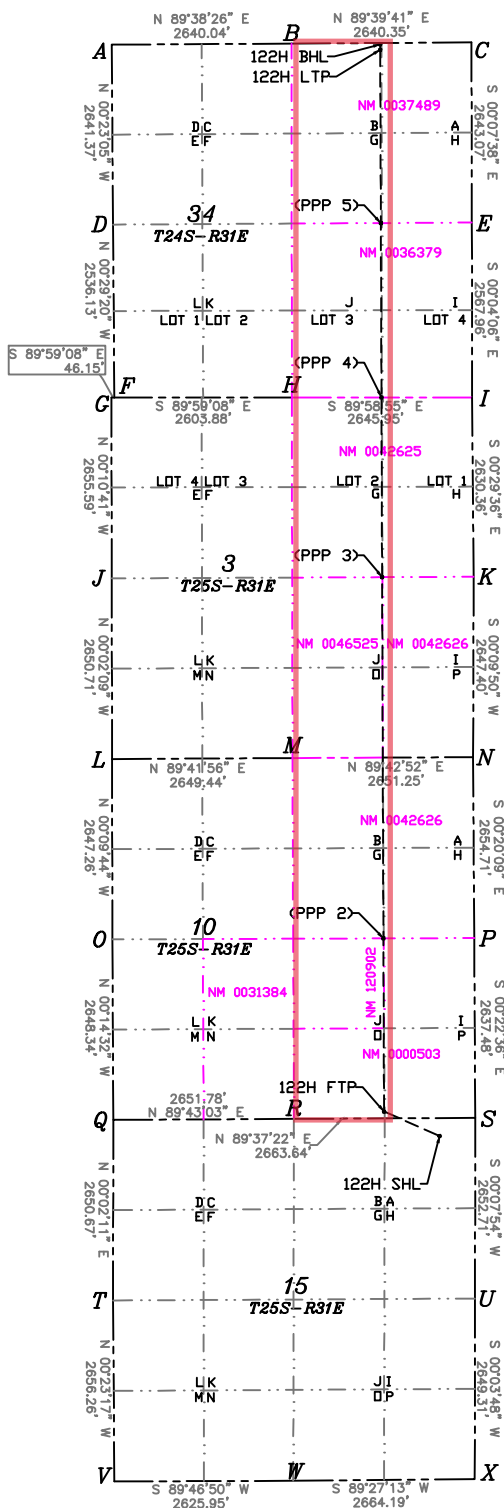

The Exmoor well is in the Paduca; Bone Spring Pool (Pool Code 96641). It is Devon's responsibility as a prudent operator to minimize reserves left in the ground. 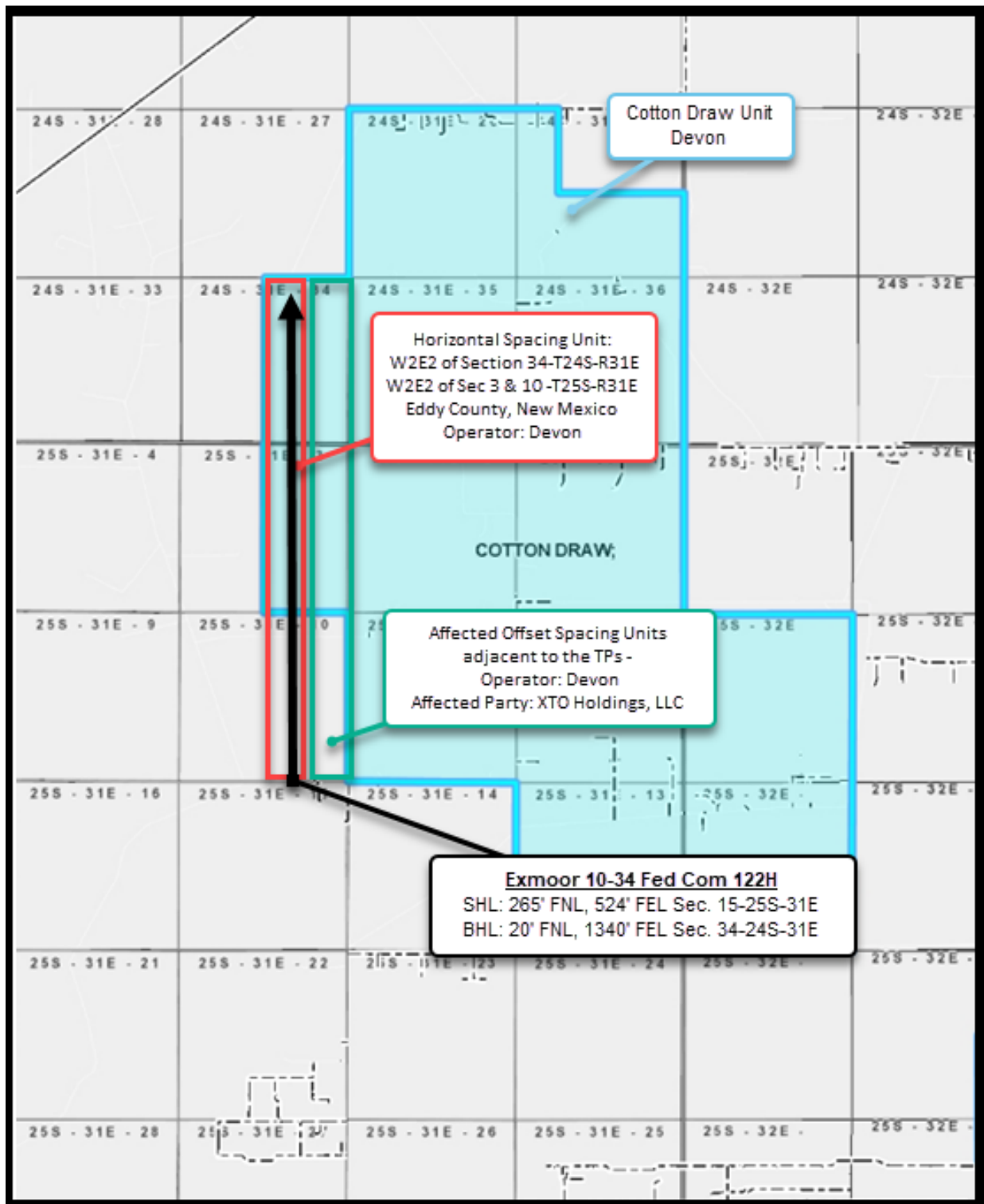
