You have requested an exception pursuant to Rule 19.15.16.15(A)(3) NMAC, to approve a non-standard horizontal spacing unit consisting of the entire area described above as the horizontal spacing unit. The proposed horizontal spacing unit does not consist of a quarter section or equivalent in both sections, as required by Rule 19.15.16.15(B)(3) NMAC.

We understand that you are seeking this exception for an allowance to create a non-standard horizontal spacing unit, comprised of the Proposed Horizontal Spacing Unit referenced above within Eddy County, New Mexico.

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in Paragraph (8) Subsection A of 19.15.2.7 NMAC, in all adjoining units which are being excluded.

You have requested this non-standard horizontal spacing unit as your preferred well spacing plan for horizontal wells underlying the N/2 S/2 Section 13 and the N/2 S/2 Sections 14 within the Wolfcamp formation, therefore protecting correlative rights within the referenced unit and adjacent tracts. The spacing unit will exclude the S/2 S/2 Section 13 and S/2 S/2 Section 14.

Pursuant to the authority conferred by Division Rule 19.15.16.15(B)(5) NMAC, the above-described **non-standard horizontal spacing unit is hereby approved**. Further, the Applicant may add additional wells to the non-standard spacing unit, the well(s) must be in the same horizontal spacing unit and pool/formation. The new well's APD shall reference this NSP order number on Form C-102 with an adjacent letter stating this request.

General Provisions

The above approvals are subject to your being in compliance with all other applicable Division rules, including, but not limited to Division Rule 19.15.5.9 NMAC.

Jurisdiction of this case is retained for the entry of such further orders as the Division may deem necessary.

Permian Resources Operating, LLC (“Permian Resources”) (OGRID No. 372165), pursuant to Division Rules 19.15.16.15(B)(5) and 19.15.15.11 NMAC, seeks administrative approval of Non-Standard Horizontal Spacing Unit for its Wombat 13 Fed 203H well, in a 320-acre, more or less, non-standard horizontal spacing unit, underlying the N/2 S/2 of Sections 13 and 14, Township 20 South, Range 28 East, Eddy County, New Mexico.

Approval of the Non-Standard Horizontal Spacing Unit is requested to allow Permian Resources to co-develop the Wombat 13 Fed 201H, Wombat 13 Fed 202H, Wombat 13 Fed 203H, and Wombat 13 Fed 204H wells.¹ If standard gas spacing is used, the ownership of the units would be split in a manner that is not representative of the actual development of the resource. Further, the non-standard spacing has been agreed to by all working interest owners and is reflected in the Joint Operating Agreements and pooling Orders for these units. If

Permian Resources is required to utilize standard spacing, the agreement would no longer be valid and additional forced pooling may be required. A non-standard spacing unit permits Permian Resources to use its preferred well spacing for the horizontal wells in this area, which will maximize recovery, prevent waste, and protect correlative rights. Therefore, Permian Resources respectfully requests approval of this non-standard spacing unit.

Exhibit A is a Form C-102 for the Wombat 13 Fed 203H well showing the location of the well in the 320-acre non-standard horizontal spacing unit.

Exhibit B is a plat for Sections 13 and 14, Township 20 South, Range 28 East, in relation to the adjoining tracts. Exhibit B also identifies the operators of the adjoining tracts.

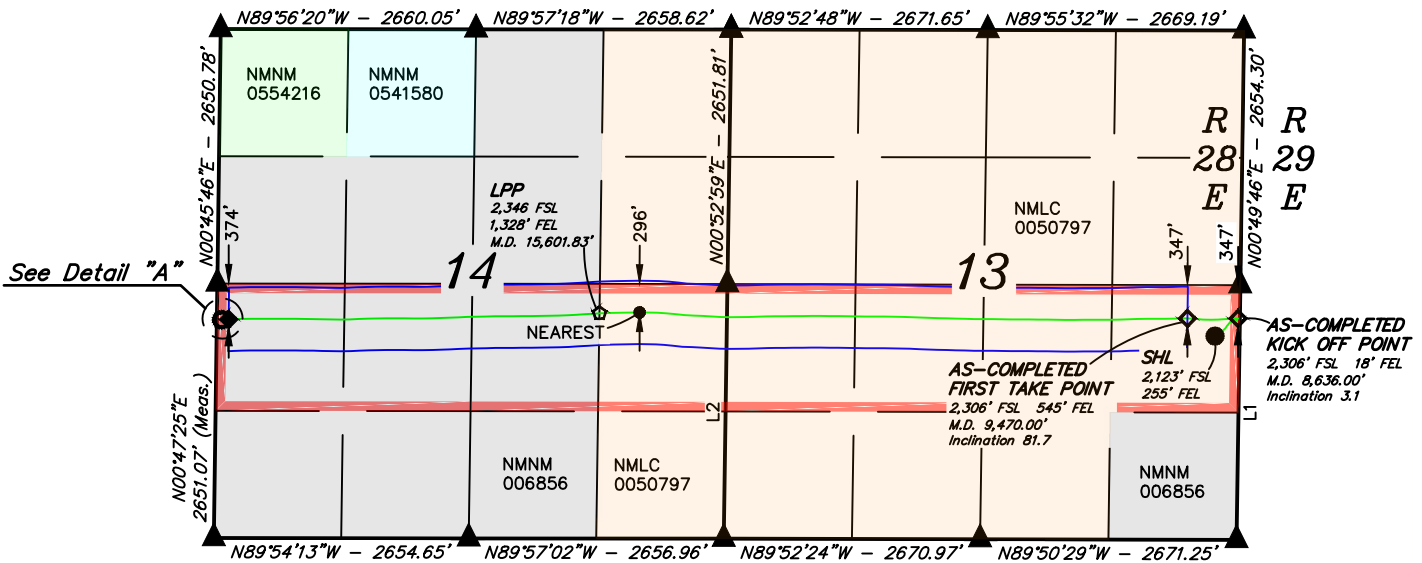

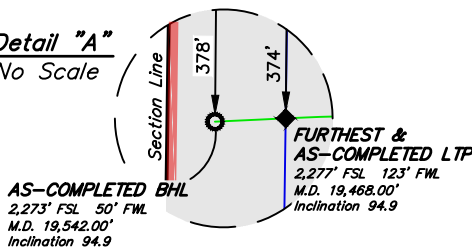
