1                   HEARING EXAMINER COSS: Now call Case Number  
2   20930, Mewbourne Energy for compulsory pooling. Are there  
3   any entries of appearance?

4                   MR. FELDEWERT: Michael Feldewert of the Santa Fe  
5   office of Holland & Hart. As I said previously MRC Permian,  
6   and MRC Permian LKE.

7                   HEARING EXAMINER COSS: You may proceed.

8                   MS. HARDY: Thank you. In Case 20930, Mewbourne  
9   seeks to pool all uncommitted mineral interests in the  
10   Wolfcamp formation in a 640 acre, more or less, standard  
11   horizontal spacing unit, comprised of the E/2 of Section 28,  
12   E/2 of Section 21, Township 23 South, Range 28 East in Eddy  
13   County.

14                   And the spacing unit will be dedicated to the  
15   Starship 28-21 W00B Fee 1H well and the Starship 28-21 W00B  
16   Fee 2H Well.

17                   The packet I provided to you includes Exhibit 1,  
18   which is the self-affirmed statement of landman Tyler Jolly,  
19   and Exhibit 2, which is a self-affirmed statement of  
20   geologist Tyler Hill.

21                   Mewbourne has complied with the notice  
22   requirements established by the provision, and that  
23   information is provided in Exhibits D and E to Mr. Jolly's  
24   affidavit, and those exhibits include the hearing notice  
25   letter -- I'm sorry -- Exhibits E and F to Mr. Jolly's

1 affidavit.

2           Exhibit E includes the notice letter and return  
3 receipt cards for mailing and Exhibit F includes the  
4 affidavit of publication.

5           So with that I would ask that Exhibits 1 and 2 be  
6 admitted into the record, and that the case be taken under  
7 advisement.

8           HEARING EXAMINER COSS: Any objection?

9           MR. FELDEWERT: No objection.

10          HEARING EXAMINER COSS: Exhibits 1 and 2 will be  
11 admitted into the record, and Case Number 20930 will be  
12 taken under advisement.
