APPLICANT'S STATEMENT OF CASE

In **Case No. 22554**, SPC seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a standard 1,282.24-acre, more or less, horizontal well spacing unit comprised of Sections 1 and 2 all in Township 22 South, Range 26 East, NMPM, Eddy County, New Mexico. Applicant seeks to dedicate the above-referenced horizontal spacing unit to the proposed **Water Buffalo 403H well**, to be horizontally drilled from a surface location in the SE/4 NE/4 (Unit H) of Section 3, Township 22 South, Range 26 East, to bottom-hole location in the NE/4 SE/4 (Unit I) of Section 1, Township 22 South, Range 26 East.

In **Case No. 22555**, SPC seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a standard 1,908.20-acre, more or less, horizontal well spacing unit comprised of Section 36, Township 21 South, Range 26 East, and irregular Section 31 and Section 32 in Township 21 South, Range 27 East, NMPM, Eddy County, New Mexico. Applicant seeks to dedicate the above-referenced horizontal spacing unit to the following proposed initial wells: (1) the **Fred 402H well**, and (2) the **Fred 442H well**, both are to be horizontally drilled from a common surface location in the SE/4 NE/4 (Unit H) of said Section 32, Township 21 South, Range 27 East, to bottom-hole locations in the SW/4 NW/4 (Unit E) of Section 36, Township 21 South, Range 27 East.
