APPLICANT’S STATEMENT OF THE CASE

Under **Case 22744**, Matador seeks an order pooling all uncommitted interests in the Bone Spring formation (Hat Mesa; Bone Spring [30213]) underlying a standard 320-acre, more or less, horizontal spacing unit comprised of the E/2 E/2 of Sections 28 and 33, Township 20 South, Range 33 East, NMPM, Lea County, New Mexico. Matador seeks to pool and initially dedicate this Bone Spring spacing unit to the proposed **Gavilon Fed Com 104H, Gavilon Fed Com 114H, Gavilon Fed Com 124H and Gavilon Fed Com 134H wells**, all to be drilled from a surface location in the SE/4 SE/4 (Unit P) of Section 33 to a bottom hole location in the NE/4 NE/4 (Unit A) of Section 28. The completed interval for each of the wells will comply with statewide setbacks for oil wells. Matador has sought and been unable to obtain voluntary agreement for the development of these lands from all working interest owners in the subject acreage.
