APPLICANT'S STATEMENT OF THE CASE

In **Case Nos. 23067** and **23068**, Matador seeks orders pooling all uncommitted interests in the Bone Spring formation (Getty; Bone Spring [27470]) underlying the referenced acreage all in Township 20 South, Range 29 East, NMPM, Eddy County, New Mexico, as follows:

- Under **Case 23067**, Matador seeks to pool a standard 240-acre, more or less, horizontal spacing unit comprised of the N/2 S/2 of Section 15 and the N/2 SW/4 of Section 14 and initially dedicate this Bone Spring spacing unit to the proposed **Ted 1514 Fed Com #123H well**, to be drilled from a surface hole location in the NW/4 SW/4 (Unit L) of Section 15 to a proposed bottom hole location in the NE/4 SW/4 (Unit K) of Section 14.
- Under **Case 23068**, Matador seeks to pool a standard 240-acre, more or less, horizontal spacing unit comprised of the S/2 S/2 of Section 15 and the S/2 SW/4 of Section 14 and initially dedicate this Bone Spring spacing unit to the proposed **Ted 1514 Fed Com #124H well**, to be drilled from a surface hole location in the NW/4 SW/4 (Unit L) of Section 15 to a proposed bottom hole location in the SE/4 SW/4 (Unit N) of Section 14.

In **Case Nos. 23069** and **23070**, Matador seeks orders pooling all uncommitted interests in the Wolfcamp formation (Burton Flat; Upper Wolfcamp, East (Oil) [98315]) underlying the referenced acreage all in Township 20 South, Range 29 East, NMPM, Eddy County, New Mexico, as follows:

- Under **Case 23069**, Matador seeks to pool a standard 240-acre, more or less, horizontal spacing unit comprised of the N/2 S/2 of Section 15 and the N/2 SW/4 of Section 14 and initially dedicate this Wolfcamp spacing unit to the proposed **Ted 1514 Fed Com #203H well**, to be drilled from a surface hole location in the NW/4 SW/4 (Unit L) of Section 15 to a proposed bottom hole location in the NE/4 SW/4 (Unit K) of Section 14.
- Under **Case 23070**, Matador seeks to pool a standard 240-acre, more or less, horizontal spacing unit comprised of the S/2 S/2 of Section 15 and the S/2 SW/4 of Section 14 and initially dedicate this Wolfcamp spacing unit to the proposed **Ted 1514 Fed Com #204H**

well, to be drilled from a surface location in the NW/4 SW/4 (Unit L) of Section 15 to a proposed bottom hole location in the SE/4 SW/4 (Unit N) of Section 14.

The completed interval for each of the wells will comply with statewide setbacks for oil wells. Matador has sought and been unable to obtain voluntary agreement for the development of these lands from all working interest owners in the subject acreage.
