**APPLICATION**

OXY USA Inc. (“Oxy”), through its undersigned attorneys, files this application with the Oil Conservation Division to amend pooling Order R-21021 to add additional parties to the terms of the pooling order. In support of its application OXY states:

1. OXY USA Inc. (OGRID No. 16696) is the designated operator under Order R-21021 entered in Case No. 20766 on January 15, 2020.

2. Order R-21021 pooled uncommitted mineral interests in the Wolfcampe formation [Purple Sage; Wolfcamp Gas Pool (98220)] underlying a standard 640-acre horizontal spacing unit comprised of the W/2 of Section 8 and Section 17, Township 24 South, Range 29 East, NMPM, Eddy County, New Mexico.

3. This standard horizontal well spacing unit is dedicated to the following initial wells:

- **Oxbow CC 17 8 Federal Com Well No. 31H** (API No. 30-015-45083), a horizontal well drilled from a surface location in the SW/4 SW/4 (Unit M) of Section 17 to a bottomhole location in the NW/4 NW/4 (Unit D) of Section 8;
- **Oxbow CC 17 8 Federal Com Well No. 32H** (API No. 30-015-45084), a horizontal well drilled from a surface location in the SW/4 SW/4 (Unit M) of Section 17 to a bottomhole location in the NW/4 NW/4 (Unit D) of Section 8;

- **Oxbow CC 17 8 Federal Com Well No. 37H** (API No. 30-015-46400), a horizontal well drilled from a surface location in the SE/4 SW/4 (Unit N) of Section 17 to a bottomhole location in the NE/4 NW/4 (Unit C) of Section 8.

4. On April 28, 2020, the Division entered Order No. R-21021-A pooling additional parties under the terms of the order.

5. Applicant has discovered interest owners who own bare record title in the pooled acreage and were not subject to the pooling proceedings giving rise to Order R-21021 or R-21021-A.

6. Applicant has sought and been unable to obtain voluntary agreement for the development of these lands from these additional owners.

WHEREFORE, Applicant requests that this application be set for hearing before an Examiner of the Oil Conservation Division on December 1, 2022, and, after notice and hearing as required by law, the Division enter an order placing this additional mineral owner under the terms of Order R-21021.

**Application of OXY USA Inc. to Amend Order R-21021 to Add Additional Pooled Parties, Eddy County, New Mexico.** Applicant seeks an order from the Division Order R-21021 to add additional parties to the terms of the pooling order. Order R-21021 pooled uncommitted mineral interests in the Wolfcamp formation [Pierce Crossing; Bone Spring Pool (50371)] underlying a standard 640-acre horizontal spacing unit comprised of the W/2 of Section 8 and Section 17, Township 24 South, Range 29 East, NMPM, Eddy County, New Mexico. This standard horizontal well spacing unit is dedicated to the following initial wells:

- **Oxbow CC 17 8 Federal Com Well No. 31H** (API No. 30-015-45083), a horizontal well drilled from a surface location in the SW/4 SW/4 (Unit M) of Section 17 to a bottomhole location in the NW/4 NW/4 (Unit D) of Section 8;
- **Oxbow CC 17 8 Federal Com Well No. 32H** (API No. 30-015-45084), a horizontal well drilled from a surface location in the SW/4 SW/4 (Unit M) of Section 17 to a bottomhole location in the NW/4 NW/4 (Unit D) of Section 8; and
- **Oxbow CC 17 8 Federal Com Well No. 37H** (API No. 30-015-46400), a horizontal well drilled from a surface location in the SE/4 SW/4 (Unit N) of Section 17 to a bottomhole location in the NE/4 NW/4 (Unit C) of Section 8.
