SECOND SELF AFFIRMED STATEMENT OF TYLER JOLLY, LANDMAN

1. My name is Tyler Jolly, and I am employed by Mewbourne Oil Company (“Mewbourne”) as a Landman. My responsibilities include the Permian Basin of New Mexico. I have previously testified before the New Mexico Oil Conservation Division as an expert witness in petroleum land matters and provided a self-affirmed statement in his matter.

2. My previous statement incorrectly described the acreage Mewbourne seeks to pool in the Wolfcamp formation as including Lot 6 (NW4SW4 equivalent) instead of Lot 7 (SW4SW4 equivalent) of irregular Section 6. The correct acreage that Mewbourne seeks to pool under Case 23172 is Lot 7 (SW4SW4 equivalent), SE4SW4, S2SE4 of irregular Section 6 and S2S2 of Section 5, Township 20 South, Range 29 East, NMPM, Eddy County, New Mexico.

3. I have confirmed that the application filed in this matter and served upon the party Mewbourne seeks to pool correctly describes the acreage.

4. I affirm under penalty of perjury under the laws of the State of New Mexico that the foregoing statements are true and correct. I understand that this self-affirmed statement will be used as written testimony in this case. This statement is made on the date next to my signature below.
