APPLICANT'S STATEMENT OF CASE

In this Case No. 22701, Legacy applies for an order to create a standard spacing and proration unit and pool all uncommitted mineral interest owners within the Bone Spring Formation (BONE SPRING [pending]) underlying the E½ of Section 33, Township 18 South, Range 31 East, N.M.P.M. and the NE¼ of Section 4, Township 19 South, Range 31 East, N.M.P.M., Eddy County, New Mexico.

Legacy seeks to dedicate the above-referenced Bone Spring Formation horizontal spacing unit to the following proposed wells:

- The **Jet Fed Com 401 H Well** (API No. Pending), the **Jet Fed Com 501 H Well** (API No. Pending), and the **Jet Fed Com 601 H Well** (API No. Pending), which will be drilled to the Bone Spring Formation, as initials well to the unit, to be horizontally drilled from a surface location in the NE¼NE¼ of Section 33, Township 18 South, Range 31 East, N.M.P.M., to a bottom hole location in the SW¼NE¼ of Section 4, Township 19 South, Range 31 East, N.M.P.M.; and
- The **Jet Fed Com 402 H Well** (API No. Pending), the **Jet Fed Com 502 H Well** (API No. Pending), and the **Jet Fed Com 602 H Well** (API No. Pending), which will be drilled to the Bone Spring Formation, as initials well to the unit, to be horizontally drilled from a surface location in the NE¼NE¼ of Section 33, Township 18 South, Range 31 East, N.M.P.M., to a bottom hole location in the SE¼NE¼ of Section 4, Township 19 South, Range 31 East, N.M.P.M..

The completed interval of the Wells will be orthodox.
