APPLICANT'S STATEMENT OF CASE

In this Case No. 23403, Legacy applies for an order to create a standard spacing and proration unit and pool all uncommitted mineral interest owners within the Bone Spring Formation underlying the W½E½ of Section 33, Township 18 South, Range 31 East, N.M.P.M. and the W½NE¼ of Section 4, Township 19 South, Range 31 East, N.M.P.M., Eddy County, New Mexico.

Legacy seeks to dedicate the above-referenced Bone Spring Formation horizontal spacing unit to the following proposed wells:

- The **Jet Federal Com 401H Well** (API No. Pending), the **Jet Federal Com 501H Well** (API No. Pending), and the **Jet Federal Com 601H Well** (API No. Pending) to be horizontally drilled to the Bone Spring Formation from a surface location in the NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 33, Township 18 South, Range 31 East, N.M.P.M., to a bottom hole location in the SW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 4, Township 19 South, Range 31 East, N.M.P.M.; and
