Order No. R-22069 pooled mineral interest owners in the Bone Spring formation underlying a horizontal spacing unit comprised of the W/2E/2 of Section 11 and the W/2SE/4 of Section 2, Township 18 South, Range 32 East, N.M.P.M., Lea County, New Mexico, for purposes of drilling the Dragonstone B2OJ Federal Com. Well No. 1H. It requires the commencement of drilling within one year of the date of the order unless the operator obtains an extension by amending the order for good cause shown.
