STATEMENT OF THE CASE

APPLICANT

Mewbourne Oil Company seeks an order pooling all uncommitted mineral interest owners in the Bone Spring formation underlying a non-standard horizontal spacing unit comprised of the S/2 of Section 10 and the S/2 of Section 11, Township 18 South, Range 29 East, NMPM. The unit will be dedicated to (a) the Seabass 10/11 Fed. Com. Well No. 526H, with a first take point in the NW/4SW/4 of Section 10 and a last take point in the NE/4SE/4 of Section 11, and (b) the Seabass 10/11 Fed. Com. Well No. 528H, with a first take point in the SW/4SW/4 of Section 10 and a last take point in the SE/4SE/4 of Section 11. Also to be considered will be the cost of drilling, completing, equipping, and testing the wells and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the wells, and a 200% charge for the risk involved in drilling, completing, equipping, and testing the wells.
