In Case No. 24267, Permian Resources applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2 N/2 of Sections 10 and 11, Township 22 South, Range 26 East, Eddy County, New Mexico. The Unit will be dedicated to the **Mammoth 10 Com 122H** and **Mammoth 10 Com 132H** wells, which will produce from first take points in the SW/4 NW/4 (Unit E) of Section 10, to last take points in the SE/4 NE/4 (Unit H) of Section 11.

The Unit will be dedicated to the **Mammoth 10 Com 124H** and

Mammoth 10 Com 134H wells, which will produce from first take points in the SW/4 SW/4 (Unit M) of Section 10, to last take points in the SE/4 SE/4 (Unit P) of Section 11.

The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Permian Resources Operating, LLC as operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells. The surface location of the wells is approximately 1 mile west of Carlsbad, New Mexico.
