FOR APPROVAL OF AN OVERLAPPING HORIZONTAL  
WELL SPACING UNIT AND COMPULSORY POOLING,  
LEA COUNTY, NEW MEXICO.**

**APPLICATION**

MRC Permian Company (“MRC” or “Applicant”), through undersigned attorneys, hereby files this application with the Oil Conservation Division pursuant to the provisions of NMSA 1978, § 70-2-17, for an order (a) approving a standard 307.96-acre, more or less, overlapping horizontal well spacing unit in the Bone Spring formation comprised of the W2W2 equivalent of irregular Sections 30 and 31, Township 18 South, Range 35 East, NMPM, Lea County, New Mexico, and (b) pooling all uncommitted interests in this horizontal well spacing unit. In support of its application, MRC states:

1. Applicant is a working interest owner in the proposed horizontal spacing unit and has the right to drill thereon.
2. Applicant seeks to designate Matador Production Company (OGRID No. 228937) as the operator of the proposed horizontal well spacing unit.
3. Applicant seeks to initially dedicate the above-referenced horizontal spacing unit to the proposed **Airstrip State Com 121H** well, to be horizontally drilled from a surface location in the NW4 of Section 30, with a first take point in the NW4NW4 equivalent (Lot 1) of irregular Section 30 and a last take point in the SW4SW4 equivalent (Lot 4) of irregular Section 31.
4. This proposed horizontal well spacing unit will overlap the following existing or proposed spacing units:

- An existing 154.28-acre spacing unit comprised of the W2W2 equivalent (Lots 1-4) of irregular Section 31, dedicated to the Airstrip 31-18S-35E RN State Com 111H (30-025-45025) and Airstrip 31-18S-35E RN State Com #131H (API: 30-025-44509) wells operated by Matador Production Company and assigned to the Airstrip; Bone Spring Pool [960].
- A proposed 313.68-acre horizontal well spacing unit comprised of the W2 equivalent of irregular Section 30 to be dedicated to Applicant's proposed Airstrip State Com 110H and 130H "u-turn" wells.

5. Applicant has sought and been unable to obtain voluntary agreement for the development of these lands from all interest owners in the subject spacing unit.

6. The pooling of this horizontal well spacing unit will allow Applicant to obtain a just and fair share of the oil and gas underlying the subject lands, avoid the drilling of unnecessary wells, will prevent waste, and will protect correlative rights.

WHEREFORE, Applicant requests that this application be set for hearing before an Examiner of the Oil Conservation Division on the September 10, 2024, special docket, and, after notice and hearing as required by law, the Division enter an order:

- A. Approving the overlapping horizontal well spacing unit and pooling all uncommitted interest owners therein;
- B. Designating Matador Production Company as operator of this overlapping horizontal spacing unit and the horizontal wells to be drilled thereon;
- C. Authorizing Applicant to recover its costs of drilling, completing, and equipping the well;

- D. Approving the actual operating charges and costs of supervision while drilling and after completion, together with a provision adjusting the rates pursuant to the COPAS accounting procedures; and
- E. Imposing a 200% charge for the risk assumed by Applicant in drilling and completing the well against any working interest owner who does not voluntarily participate in the drilling of the well.

CASE \_\_\_\_\_: **Application of MRC Permian Company for Approval of an Overlapping Horizontal Well Spacing Unit and Compulsory Pooling, Lea County, New Mexico.** Applicant in the above-styled cause seeks an order (a) approving a standard 307.96-acre, more or less, overlapping horizontal well spacing unit in the Bone Spring formation comprised of W2W2 equivalent of irregular Sections 30 and 31, Township 18 South, Range 35 East, NMPM, Lea County, New Mexico, and (b) pooling all uncommitted interests in this horizontal well spacing unit. Said unit will be initially dedicated to the proposed **Airstrip State Com 121H** well, to be horizontally drilled from a surface location in the NW4 of Section 30, with a first take point in the NW4NW4 equivalent (Lot 1) of irregular Section 30 and a last take point in the SW4SW4 equivalent (Lot 4) of irregular Section 31. This proposed horizontal well spacing unit will overlap the following existing or proposed spacing units:

- An existing 154.28-acre spacing unit comprised of the W2W2 equivalent (Lots 1-4) of irregular Section 31, dedicated to the Airstrip 31-18S-35E RN State Com 111H (API: 30-025-45025) and Airstrip 31-18S-35E RN State Com 131H (API: 30-025-44509) wells operated by Matador Production Company and assigned to the Airstrip; Bone Spring [960].
- A proposed 313.68-acre horizontal well spacing unit comprised of the W2 equivalent of irregular Section 30 to be dedicated to Applicant's proposed Airstrip State Com 110H and 130H "u-turn" wells.

Also, to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, actual operating costs and charges for supervision, designation of Matador Production Company as operator of the proposed spacing unit, and a 200% charge for risk involved in drilling said well. The subject area is located approximately 20 miles west of Hobbs, New Mexico.
