**STATEMENT OF THE CASE**

Applicant seeks an order pooling all uncommitted mineral interests in the Bone Spring formation underlying a non-standard horizontal spacing unit comprised of Sections 10, 11, and 12, Township 20 South, Range 27 East, New Mexico NMPM (containing 1920 acres) (“Unit”).

The Unit will initially be dedicated to (a) the Shark Week 12/10 Fed. Com. Well No. 622H, with a first take point in the NE/4NE/4 of Section 12 and a last take point in the NW/4NW4 of Section 10, and (b) the Shark Week 12/10 Fed Com. Well No. 624H, with a first take point in the SE/4NE/4 of Section 12 and a last take point in the SW/4NW/4 of Section 10.

The completed interval for the wells will be orthodox. Also to be considered will be the costs of drilling and completing the wells and the allocation of the costs, the designation of Mewbourne Oil Company as the operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.
