**MOTION TO AMEND PRE-HEARING ORDER**

The parties in this matter, specifically Magnum Hunter Production, Inc. (along with its subsidiaries and affiliates Cimarex Energy., Cimarex Energy Company of Colorado, Coterra Energy, Inc.) (collectively Magnum Hunter) move to amend the Pre-Hearing Order for the above-referenced cases to remove Case Nos. 24684- 24687 and to add Case No. 24913 – 24916.

In support of this motion, the Parties state as follows:

1. The Division issued a Pre-Hearing Order dated July 26, 2024, consolidating Case Nos. 24632, 24633, and 24684-24687 and setting them for contested hearing on September 17, 2024.
2. The Division issued an Amended Pre-Hearing Order dated August 27, 2024, consolidating additional Case Nos. 24756-24767, and setting them for contested hearing on October 8, 2024.

3. The Division issued a subsequent Amended Pre-Hearing Order dated October 1, 2024, moving the hearing date for the Special Docket to November 5, 2024.

4. On September 3, 2024, Magnum Hunter engaged new counsel to represent it in its cases related to the Special Docket Hearing. Subsequently, around October 4, 2024, newly retained counsel for Magnum Hunter discovered that the depths described in Magnum Hunter's applications for its Bone Spring wells contained an error and that amended or new applications needed to be filed with the Division.

5. Mangum Hunter then filed new applications with the Division for its Bone Spring wells on October 4, 2024 and those applications were assigned case numbers 24913 – 24916. These cases were set on the November 5, 2024 special docket by the Division.

6. Magnum Hunter filed a motion with the Division to dismiss its previously filed Bone Spring well applications, Case Nos. 24685- 24687 on October 11, 2024 and provided notice to all of the parties who had entered appearances in those cases.

7. The Division is able to provide notice of the Special Docket set for November 5, 2024, pursuant to Rule 19.15.4.9 NMAC of all the cases set on that docket, including Case Nos. 24913 – 24916

8. All Parties are continuing to engage in good faith settlement negotiations, and there is a possibility that some portion of the contested matters can be resolved prior to a contested hearing. However, the matters have not been resolved and the parties are working to prepare for the November 5, 2024 hearing.

9. As such, Mangum Hunter respectfully requests that Case Nos. 24913 – 24916 be added to the Pre-Hearing Order and consolidated for hearing with the other listed cases and that Case Nos. 24684 -24687 be removed since these cases have been dismissed.

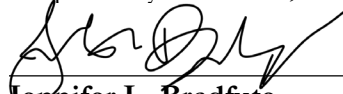
10. Magnum Hunter has reached out to the other parties in the above-listed cases to seek their concurrence with this motion.

12. Counsel for the other parties in the cases set for hearing on November 5th were contacted about this motion and proposed order and have no objections. The counsel for COG Operating and Concho Oil and Gas and Avant Operating, LLC do not object to the filing of this motion, counsel for MRC Permian Company, Forman Oil Company and Permian Resources Operating, LLC confirmed they have no concerns with the form of the motion and proposed order, and counsel for Franklin Operating takes no position on this motion.

WHEREFOR, Mangum Hunter respectfully requests that Case Nos. 24913 – 24916 be added to the Pre-Hearing Order and consolidated for hearing with the other listed cases and that Case Nos. 24684 -24687 be removed since these cases have been dismissed.

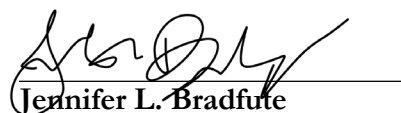
