STATEMENT OF THE CASE

APPLICANT

In Case No. 25285, Applicant has filed an application with the Division for an order pooling all uncommitted mineral interest owners in the Bone Spring formation underlying a non-standard spacing unit comprised of the E/2 of Section 12, Township 20 South, Range 28 East, NMPM and all of Sections 7 and 8, Township 20 South, Range 29 East, NMPM, Eddy County, New Mexico (the "Unit"). Applicant proposes to drill the following wells in the Unit:

- (a) The Jericho 8/12 Fed. Com. Well No. 621H, with a first take point in the NE/4NE/4 of Section 8 and a final take point in the NW/4NE/4 of Section 12;

- (b) The Jericho 8/12 Fed. Com. Well No. 624H, with a first take point in the SE/4NE/4 of Section 8 and a final take point in the SW/4NE/4 of Section 12; and
- (c) The Jericho 8/12 Fed. Com. Well No. 627H, with a first take point in the SE/4SE/4 of Section 8 and a final take point in the SW/4SE/4 of Section 12.

In Case No. 25286, Applicant has filed an application with the Division for an order pooling all uncommitted mineral interest owners in the Wolfcamp formation underlying a non-standard spacing unit comprised of the E/2 of Section 12, Township 20 South, Range 28 East, NMPM and all of Sections 7 and 8, Township 20 South, Range 29 East, NMPM, Eddy County, New Mexico (the "Unit"). Applicant proposes to drill the following wells in the Unit:

- (a) The Jericho 8/12 Fed. Com. Well No. 712H, with a first take point in the NE/4NE/4 of Section 8 and a final take point in the NW/4NE/4 of Section 12;
- (b) The Jericho 8/12 Fed. Com. Well No. 715H, with a first take point in the NE/4SE/4 of Section 8 and a final take point in the NW/4SE/4 of Section 12; and
- (c) The Jericho 8/12 Fed. Com. Well No. 718H, with a first take point in the SE/4SE/4 of Section 8 and a final take point in the SW/4SE/4 of Section 12.

Also to be considered will be the cost of drilling, completing, testing, and equipping the wells, and the allocation of the cost thereof among the wells' working interest owners, designation of Applicant as operator of the wells and the Units, approval actual operating charges and costs charged for supervision, together with a provision adjusting the rates pursuant to the COPAS accounting procedure, and setting a 200% charge for the risk involved in drilling, completing, testing, and equipping the wells in the event a working interest owner elects not to participate in the wells.
