**SELF-AFFIRMED STATEMENT
OF KRISTEEN RAMOS**

1. I am a Landman with BTA Oil Producers, LLC ("BTA") I am over 18 years of age, have personal knowledge of the matters addressed herein, and am competent to provide this Self-Affirmed Statement. I have previously testified before the New Mexico Oil Conservation Division ("Division"), and my credentials as an expert in petroleum land matters were accepted and made a matter of record.

2. I am familiar with the land matters involved in the above-referenced case. Copies of BTA's Application and proposed hearing notice are attached as **Exhibit A-1**.

3. None of the parties proposed to be pooled in this case indicated opposition to this matter proceeding by affidavit, therefore I do not expect any opposition at hearing.

4. BTA applies for an order pooling all uncommitted interests in the Second Bone Spring interval of the Bone Spring formation underlying a 400-acre, more or less, standard horizontal spacing unit comprised of the E/2 NW/4 of Section 25 and the E/2 W/2 of Sections 24 and 13, Township 20 South, Range 35 East, Lea County, New Mexico ("Unit").

5. The Unit will be dedicated to the **Sage Brush 22302 25-24-13 State Com #4H** well ("Well"), to be drilled from a surface hole location in the SW/4 NW/4 (Unit E) of Section 25 to a bottom hole location in the NE/4 NW/4 (Unit C) of Section 13.

6. The completed interval of the Well will be orthodox.

7. Depth severances exist within the Unit. The depth severance at the top of the Second Bone Spring interval is found at approximately 9,538' TVD, and the depth severance at the top of the Third Bone Spring interval is found at approximately 10,402' TVD, as shown on the RSC Resources LP– Heller Co Trust Com “A” 1 well (API No. 30-025-28193) type log. BTA is only seeking to pool interests in the Second Bone Spring interval between these depths.

8. **Exhibit A-2** contains C-102s for the Well.

9. **Exhibit A-3** contains a plat that identifies ownership by tract in the Unit. This exhibit also includes any applicable lease numbers, a unit recapitulation, and the interests BTA seeks to pool highlighted in yellow.

10. **Exhibit A-4** contains a plat that identifies the two (2) pools in the Unit.

11. **Exhibit A-5** contains a sample well proposal letter, formation clarification letter, and AFE sent to the working interest owners for the Well. The estimated costs reflected on the AFEs are fair and reasonable and comparable to the cost of other wells of similar depth and length drilled in the subject formation in the area.

12. BTA has conducted a diligent search of all county public records, including phone directories, internet searches, and computer databases, to identify all potential addresses and contact information for each interest owner it seeks to pool.

13. In my opinion, BTA made a good-faith effort to reach voluntary joinder of uncommitted interests in the Well as indicated by the chronology of contact described in **Exhibit A-6**.

14. BTA requests overhead and administrative rates of \$12,000.00 per month while the Well is being drilled and \$1,200.00 per month while the Well is producing. These rates are fair and are comparable to the rates charged by BTA and other operators in the vicinity.

15. The attached exhibits were either prepared by me or under my supervision or were compiled from company business records.

16. In my opinion, the granting of BTA's application will serve the interests of conservation, the protection of correlative rights, and the prevention of waste.

17. I understand this Self-Affirmed Statement will be used as written testimony in this case. I affirm my testimony above is true and correct and is made under penalty of perjury under the laws of the State of New Mexico. My testimony is made as of the date identified next to my signature below.

APPLICATION

Pursuant to NMSA 1978, Section 70-2-17, BTA Oil Producers, LLC (OGRID No. 260297) (“BTA” or “Applicant”) applies for an order pooling all uncommitted interests in the Second Bone Spring interval of the Bone Spring formation underlying a 400-acre, more or less, standard horizontal spacing unit comprised of the E/2 NW/4 of Section 25 and the E/2 W/2 of Sections 24 and 13, Township 20 South, Range 35 East, Lea County, New Mexico (“Unit”). In support of this application, BTA states the following.

1. Applicant is a working interest owner in the Unit and has the right to drill wells thereon.
2. The Unit will be dedicated to the **Sage Brush 22302 25-24-13 State Com #4H** well (“Well”), to be drilled from a surface hole location in the SW/4 NW/4 (Unit E) of Section 25 to a bottom hole location in the NE/4 NW/4 (Unit C) of Section 13.
3. The completed interval of the Well will be orthodox.
4. A depth severance exists within the Unit. Therefore, BTA seeks to pool only those uncommitted interests from the top of the Second Bone Spring interval, at a stratigraphic equivalent of approximately 9,538’ TVD, to the top of the Third Bone Spring interval, at a stratigraphic equivalent of approximately 10,402’ TVD, as found in the RSC Resources LP – Heller Co Trust Com “A” 1 well (API No. 30-025-28193).

5. Applicant has undertaken diligent, good-faith efforts to obtain voluntary agreements from all interest owners to participate in the drilling of the Well but has been unable to obtain voluntary agreements from all interest owners.

6. The pooling of uncommitted interests will avoid the drilling of unnecessary wells, prevent waste, and protect correlative rights.

7. In order to allow Applicant to obtain its just and fair share of the oil and gas underlying the subject lands, all uncommitted interests in the Unit should be pooled and Applicant should be designated as the operator of the Well and Unit.

WHEREFORE, Applicant requests that this application be set for hearing before an Examiner of the Oil Conservation Division on July 10, 2025, and, after notice and hearing as required by law, the Division enter an order:

- A. Pooling all uncommitted interests in the Unit;
- B. Approving the Well in the Unit;
- C. Designating Applicant as operator of the Unit and the Well to be drilled thereon;
- D. Authorizing Applicant to recover its costs of drilling, equipping and completing the Well;
- E. Approving the actual operating charged and costs of supervision while drilling and after completion, together with a provision adjusting the rated pursuant to the COPAS accounting procedures; and
- F. Imposing a 200% penalty for the risk assumed by Applicant in drilling and completing the Well against any working interest owner who does not voluntarily participate in the drilling of the Well.

SELF-AFFIRMED STATEMENT OF DARIN DOLEZAL

1. I am employed by BTA Oil Producers, LLC ("BTA"). I am over 18 years of age, have personal knowledge of the matters addressed herein, and am competent to provide this Self-Affirmed Statement. I have previously testified before the New Mexico Oil Conservation Division ("Division"), and my credentials as an expert in petroleum geology matters were accepted and made a matter of record.

2. I am familiar with the geological matters that pertain to the above-referenced case.

3. **Exhibit B-1** is a project location map that shows the location of the proposed **Sage Brush 22302 25-24-13 State Com #4H** well ("Well").

4. BTA is targeting the Bone Spring Formation. **Exhibit B-2** is a subsea structure map that I prepared with 100-foot contours. The proposed horizontal spacing unit is highlighted in red and the initial well is depicted with a black dashed line. Existing producing wells in the Bone Spring Formation are represented by solid orange lines. The structure map shows Bone Spring Formation. The structure appears consistent across the proposed spacing unit, and I do not observe any faulting, pinch outs, or other geologic impediments to drilling horizontal wells in this area.

5. **Exhibit B-2** also shows a cross-section line in blue running North to South reflecting three wells penetrating the Bone Spring Formation that I used to construct a stratigraphic cross-section from A to A'. These wells contain good logs, and I consider them representative of the geology in the subject area.

6. **Exhibit B-3** is a stratigraphic cross-section that I prepared using the logs from the three wells noted on Exhibit B-2. Each well in the cross-section contains gamma ray in the first track and resistivity in the second track. The initial target interval is labeled and marked. This exhibit also shows 2 depth severances with red dotted lines at 9,538' and 10,402' TVD. The cross-section demonstrates that the targeted interval is continuous across the proposed spacing unit.

7. **Exhibit B-4** is a Gross Isopach map of the Second Bone Spring interval. The proposed horizontal spacing unit is highlighted in red, and the initial well is depicted with a black dashed line. Existing producing wells in the Bone Spring Formation are represented by solid orange lines. The anticipated gross thickness of the Second Bone Spring interval is 500 ft. The gross isopach map demonstrates that the Second Bone Spring interval is present across the proposed spacing unit. The location of the previous cross-section from A-A' in Exhibit B-2 is also shown as a blue line on this map.

8. In my opinion, a laydown orientation for the Well is appropriate to properly the subject acreage because of an established directional pattern and the known fracture orientation in this portion of the trend. Laydown is also supported by a study of the production of stand-up vs laydown orientation in this area, with laydown well results being significantly better.

9. Based on my geologic study, the Bone Spring Formation underlying the subject area is suitable for development by horizontal wells and the acreage comprising the proposed spacing unit will be productive and contribute proportionately to the production of the Well.

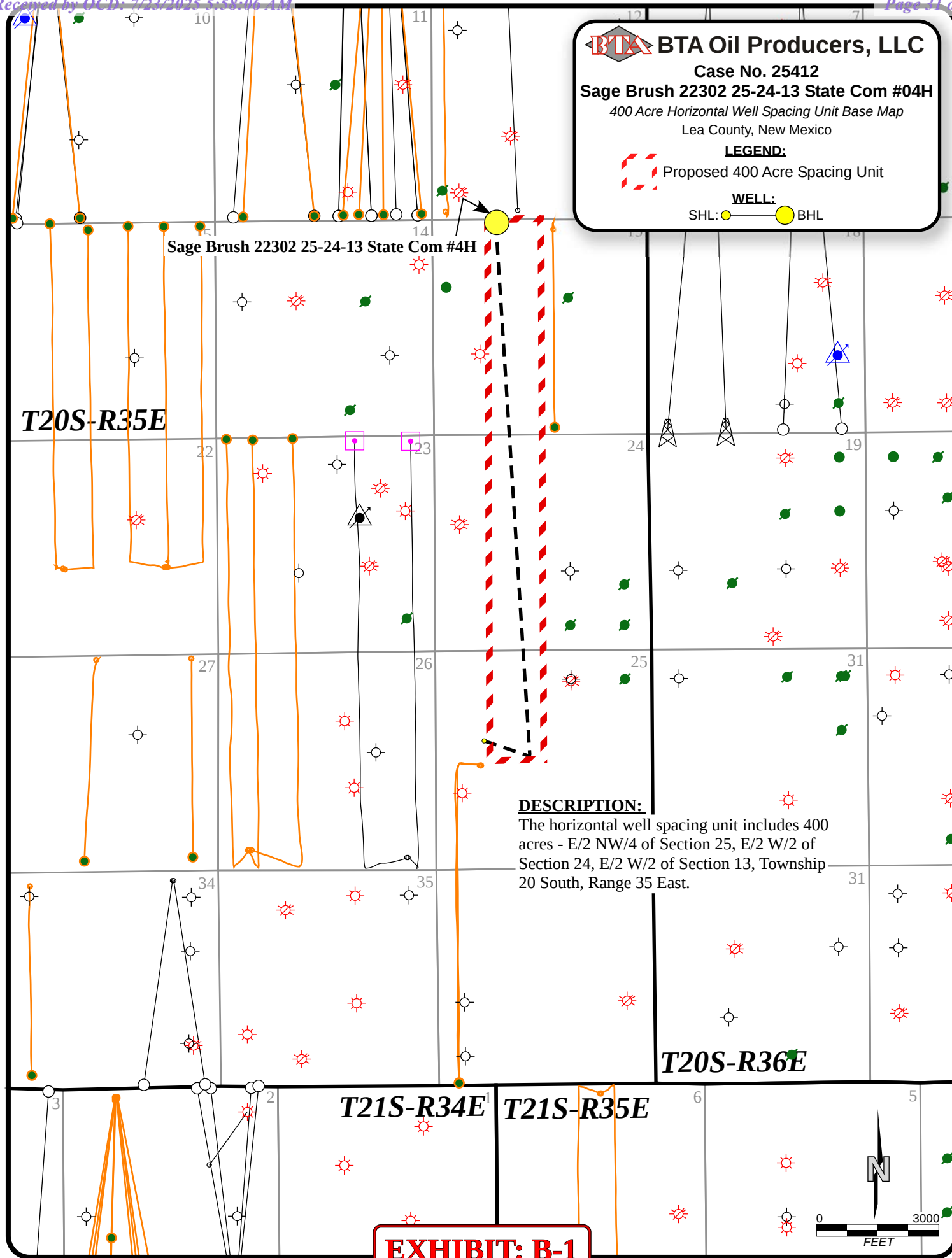
10. In my opinion, the granting of BTA's application will serve the interests of conservation, the protection of correlative rights, and the prevention of waste.

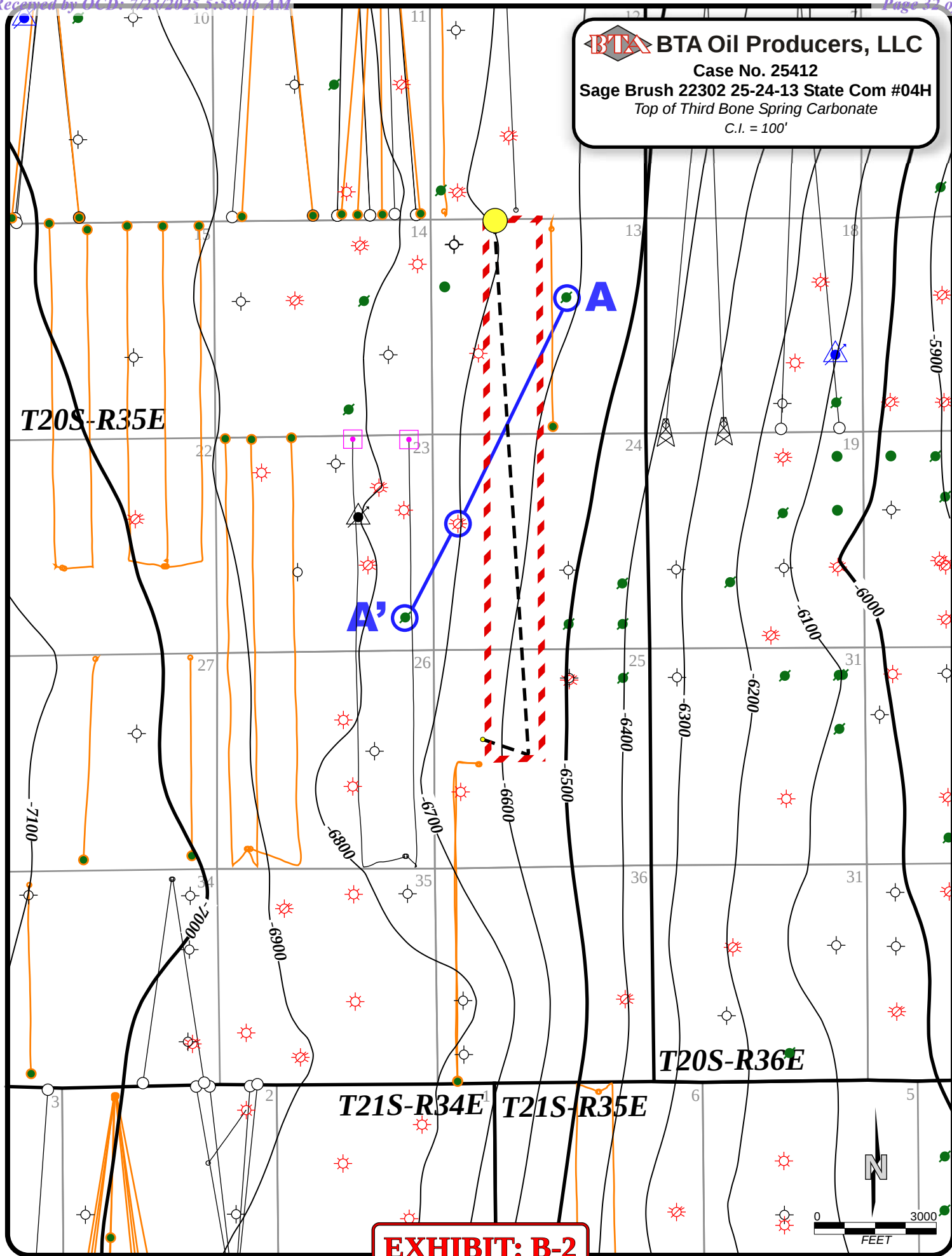
