MOTION TO AMEND PRE-HEARING ORDER

Cimarex Energy Co. of Colorado (“Cimarex”) respectfully moves to amend the Pre-Hearing Order setting the above captioned 3R Operating, LLC (“3R”) cases for a contested hearing on August 26, 2025, to add a recently filed case to the Pre-Hearing Order. In support, Cimarex states:

1. Case Nos. 25321 and 25322 are currently set for a contested hearing on August 26, 2025 for a contested hearing pursuant to a pre-hearing order issued by the Division on May 22, 2025.
2. On July 8, Cimarex filed applications that compete with 3R’s Case Nos. 25321 and 25322. Cimarex’s cases were assigned Case Nos. 25506 and 25507.

3. The Pre-Hearing Order setting Case Nos. 25321 and 25322 for a contested hearing on August 26, 2025 should thus be amended to add Cimarex Case Nos. 25506 and 25507.

4. Counsel for 3R and for Civitas Permian Operating, LLC were contacted and do not object to the motion.

WHEREFORE, Cimarex respectfully requests that the Division amend the Pre-Hearing Order as outlined herein. A proposed word version of an order granting this motion will be sent to the Division via email.
